    - (c) Response to Submissions prepared by PJEP Environmental Planning Pty Ltd, dated July 2015;
    - (d) Section 96 modification application SSD 6801 MOD 1 including Statement of Environmental Effects prepared by PJEP Environmental Planning Pty Ltd dated 4 May 2016;
    - (e) Section 96 modification application SSD 6801 MOD 2 including Statement of Environmental Effects prepared by PJEP Environmental Planning Pty Ltd dated 21 July 2016 and Response to Submissions dated 22 August 2016;

- (f) Section 96 modification application SSD 6801 MOD 3 and Statement of Environmental Effects prepared by PJEP Environmental Planning Pty Ltd dated 17 February 2017 and Response to Submissions dated 23 March 2017;
- (g) Section 96 modification application SSD 6801 MOD 4 and Statement of Environmental Effects prepared by PJEP Environmental Planning Pty Ltd dated 5 June 2017;
- (h) Section 96 modification application SSD 6801 MOD 5 and Statement of Environmental Effects prepared by PJEP Environmental Planning Pty Ltd dated 8 November 2017;
