Re: Landowner's consent for Section 96 (1A) modification to SSD 6835.
Legal Description (of ANSTO's land): Lot 101 in DP 1009354 and Lot 2 in DP 605077.
Land known as: Lucas Heights Resource Recovery Park (the "Park")

As proprietor of land affected by SSD 6835, ANSTO is informed by SUEZ Recycling & Recovery (SUEZ) (as its tenant) that, together with its joint applicant Sutherland Shire Council, it intends to lodge a consent modification to DA 11-01-99 (reference clause 26) to modify Clause C53 of SSD 6835 to allow the following operating hours at the Park:

As can be seen, the changes are limited to extending the Park's Landfill operating hours by providing one (1) hour earlier opening on weekdays, and two (2) hours earlier opening on Saturdays.

ANSTO understands the purpose of the proposed modification is to address existing and potential future queuing issues at the site entrance prior to the site opening.

As owner of lot 101 in DP 1009354 and Lot 2 in DP 605077, being a significant portion of the land at the Park, we confirm our consent to the lodgement of the proposed Section 96(1) modification to SSD 6835.
