(b) Schedule 2 Part E - Condition E16 is added by the insertion of the **bold and underlined** word/numbers as follows:

## Landscaping (kiosk substation)

E16. Prior to the issue of a final Occupation Certificate, the Applicant must submit a Landscape Plan to the satisfaction of the Secretary in consultation with Council. The plan must detail proposed replanting to compensate for the removal of the Brush Box tree required for the installation of the proposed kiosk substation. The plan must provide for the planting of at least two canopy trees, including at least one on the Miller Street frontage of the site. The trees shall be at least 3m high at the time of planting and be capable of reaching a mature height of 10m.

<u>The approved landscaping shall be undertaken prior to the issue of a final</u> <u>Occupation Certificate.</u>
