1. Delete the development description and replace with the following:

**Development:** 

Construction and operation of a warehouse and distribution facility with ancillary office, comprising the following:

- · demolition of existing buildings and associated vegetation clearance;
- site preparation, bulk earthworks and retaining wall construction;
- construction of five buildings with a total maximum gross floor area of 123,865 m<sup>2</sup>, including 5,930 m<sup>2</sup> of ancillary office facilities for the purpose of warehouse and distribution centres, light industry, technology uses, freight logistic facilities, associated administrative office premises and an industrial retail outlet and industrial training facility ancillary to the industry in a portion of warehouse lot 2;
- construction of a new internal access road, hardstand areas, car parking and loading docks;
- ancillary infrastructure and services;
- landscaping; and
- subdivision.

#### In the list of Definitions

2. Delete the definition for 'Development' and insert the following definitions in alphabetical order:

Development

The Development as described in the EIS and RTS approved by this development consent and modified by SSD 6962 MOD 1 for the demolition of existing buildings. associated vegetation clearance, earthworks, construction of warehouse and distribution

facilities with ancillary offices, car parking and associated landscaping

3. Insert the following new definition in alphabetical order:

- 5. Delete and replace Condition B7 as follows:
  - B7. This consent is limited to the construction and operation of the facility as described in the EIS, RTS only and SSD 6962 MOD 1.
- Delete and replace Condition B8 as follows: 6.
  - B8. The Applicant must ensure that the total building area does not exceed:
    - 117.935 m<sup>2</sup> of warehouse and distribution uses: (a)
    - 5,930 m<sup>2</sup> of ancillary office area; (b)
    - 493 m<sup>2</sup> of industry space; (c)
    - 180 m<sup>2</sup> of industrial retail outlet. (d)
- Insert new Condition B8A as follows: 7.
  - B8A. The industrial retail outlet associated with warehouse 2 must only be operated ancillary to an approved industry.
