## Dear Peter, Jane

The University of Sydney refers to our S96 Applications for variation to proposed conditions for Public Art installation in relation to:

\* condition B6 for the F23 consent SSD 7055; and

\* condition B8 for the LEES1 consent SSD 7054,

and in particular the City of Sydney's recent response received today (attached).

As a Crown applicant, the University advises that it does not agree with the City's proposed amended wording of these conditions for the following reasons:

- 1. Inserting "*prior to the commencement of any new building works*." puts the projects in breach of the condition as new works have already commenced;
- 2. The University proposed the S96 amendments to allow the University appropriate time to address and resolve a suitable and quality public art solution for this site and project. The proposed wording by CoS maintains the timing constraint of the original condition, and which is unattainable and unreasonable, for reasons already explained in our original S96 applications. In short, Council's response provides no change to the original condition;

For the reasons outlined above, and those reasons outlined in the University's S96 Application for Modification submissions, we request the Department to consider the amendments of these

conditions as originally proposed by the University in its' S96 applications issued on 7 February 2017.
