i write as local council resident to object to the amended DA for increased height of the approved tower at 1 Alfred St.

the extra height will cause overshadowing of the builings behind and south-east and south-west, with no public benefit. and cause overshadowing of Australia Square plaza which is enjoyed by many in our city. it will modify the current height limit laws in place, with no public benefit.

this tower and its planning keeps on changing. in 2011 the final height was determined to overurle LEP with no public benefit (which already was too tall0, and it was done so that the tower would be finished by 2014. DA granted in 2012. It seems city of sydney keeps granting more and more height to the various developers of this stie, with no difference to the existing occupants of the city - but residences an offfices.

it is poor town planning to place tall towers on the harbours edge which block views of those behind (who relyed on the existing LEP laws to maintain height of 110m) and especially at circulra quay, which cause shadows to the south etc for which there is no public benefit but an overseas developer's profits.

i would ask that council not modify the current DA which already gives a boon to the developer of extra height above longstanding (until late 2011) of 110m height.

no public benefit and no consideration is giveing for alterting the current height rules. this is not a case of views being obscrued within existing building rules but council modifiying the building heights for no public benefit.
