Dear Matthew,

United Wambo Open Cut Mine (SSD 7142) Condition E7

I refer to condition E7 in Part E of Schedule 2 of development consent SSD 7142 for the United Wambo Open Cut Coal Mine (United Wambo). Condition E7 contains the following requirement.

E7. Within three months of:

- (a) the submission of an incident report under condition E9;
- (b) the submission of an Annual Review under condition E11;
- (c) the submission of an Independent Environmental Audit under condition E12; or
- (d) the approval of any modification of the conditions of this consent,

the suitability of existing strategies, plans and programs required under this consent must be reviewed by the Applicant.

United Wambo submitted an Independent Environmental Audit (IEA) in accordance with condition E12 on 24 March 2021 and the Annual Review in accordance with condition E11 on 31 March 2021. United Wambo are therefore required to review and submit any updates to strategies, plans and programs required under SSD 7142 by 24 June 2021. Table 1 provides a summary of the documents that have been reviewed.
