We are very worried about what the coal mine will mean for our water supply especially when the EIS notes that 93 bores on 71 properties will be affected by water drawdown and this impact will remain for between 36 – 65 years after mining is finished. This creates a very uncertain future for many, many years to come.

It also states that it is expected that some bores affected may never fully recover. What does that mean for our farming enterprise? Will we be forced to sell and relocate and start again?

I object to this proposal and recommend that it be rejected due to the many significant impacts this project would have on water, noise, air quality, the local native habitat, the local economy, and the health and well being of the local community. To summarise:

- Toxic mine waste water is a pollution risk to the local river system which is part of the Sydney drinking water catchment. I live in Mittagong on the western edge of town, less than 15kms from the proposed Hume Coal site in Berrima in the NSW Southern Highlands and I object to the Hume Coal Project and the Berrima Rail Project for the following reasons:

I work at a large independent Catholic high school in Burradoo near Bowral. The school was established in 1946 and currently has 1100 enrolled students and approx. 150 staff members. I have worked in the education sector for over 20 years in administrative support roles and, as such, I am keenly aware of the importance of keeping communities together and working to develop opportunities for our young people so they can stay and find employment in a rural region such as the Southern Highlands.

I am also the mother of two young adult sons, both of whom have been gainfully employed in the robust hospitality industry in the Southern Highlands during the past 12 years. We moved from Sydney to the Southern Highlands in 1999 and during this time my husband and I have raised our family, run three businesses and served our community through education, entertainment, sporting and commercial enterprises.

I and my family are concerned that the proposed Hume Coal Project EIS SSD 7172 and the Berrima Rail Project EIS SSD 7171 will impact negatively on the enterprises, health and prosperity of our community and the food and beverage production of the Southern Highlands – one of the fastest growing regions in Australia for education, hospitality, wine, food, tourism, agriculture, viticulture, beef, lamb, horse studs and paddock to plate culture.

I have watched the steady growth of the region since moving here in 1999, with 1000s more people making a 'tree change' move to the NSW Southern Highlands – and raising their families in one of the many large urban housing developments that have sprung up here over the past 20 years. The entire premise of our business is as an eco-friendly, environmentally aware company, following best practice with our own products and the products we represent. The ethos and mission statement we follow reaches like-minded customers who expect the highest level of environmental stewardship from our business.

#### Risks to health from coal dust:

We are terribly concerned that the precious water resource we depend upon entirely for our business will be negatively impacted by the proposed mining activity of the Hume Coal Project.

We are also very concerned about the coal dust particulates from the coal stack at the proposed Berrima mine site and from transportation via railway of coal across our region – rolling through the landscape where 1000s of children will be exposed to the pollution. I am a local resident with a particular interest in making sure our local community continues to thrive. The above Projects will impact in many ways.

The major industry in the area is Tourism which employs MANY people and a great variety of industries. It covers a wide area of the Shire, particularly close to the proposed mine area. Noise, pollution and visual amenity will badly impact this industry putting many people out of work. A new report by The Australia Institute found that Hume Coal's mine could damage the total economy of the Southern Highlands as it is so dependent on Tourism which would be seriously impacted.

With modern mining techniques, other than in the set up stage, the mine will NOT provide the area with many new jobs. Most mining these days is automated and if the proposal is not to do so the viability will be decreased. The promise of increased employment is a complete furphy.

The local population do NOT support the mine development. In fact a recent survey indicated that only 18% do support it's development. The other 82% are strongly against the proposal.

The Highlands area is part of the Sydney drinking water catchment and the risk of toxic mine waste polluting this is too critical to be ignored. It is a risk we cannot afford to take, neither for ourselves nor for future generations. I understand that there are close to 100 water bores which will also be seriously affected if the ground water aquifer is fractured in any way. The fact that POSCO has offered to truck in water if this happens suggests that they are not totally sure that it wont happen. Many of our residents run feed animals requiring a reliable water supply and this would be in jeopardy. We cannot take the risk.

We are also very concerned by the health risks of dangerous coal dust and diesel emissions from the huge number of trains daily. With a high proportion of elderly in the area this pollution will pose an even greater health risk, resulting in a lower quality of life for many people, many of whom have lived in the area for many years. This will destroy rich heritage and farmland areas.

Hume Coal's trains will add an extra 24 minutes of closures at rail level crossings every day. This creates unacceptable delays on emergency service response times, quite apart from the total inconvenience to local people. The road development in the Highlands is such that there is often no alternative road route once the crossings are closed to rail traffic. Overpasses or underpasses would be a solution but prohibitively expensive to the Rail Project.

Most importantly though is the fact that we should NOT be mining unsustainable fossil fuels, let alone opening a new mine. The detrimental impacts of burning coal over the short and long term have demonstrated health, climate and economic risks. 30 years ago I attended a lecture by the eminent British scientist David Stern, who even then warned of the huge problems facing the world over climate change and the impacting problems on the environment of people and governments not doing enough to abate the problem. I am totally opposed to the environmental pollution this coal will cause at home, let alone coal exported to Korea and Vietnam. I believe that only the Mining Industry Council is in favour of opening new mines in Australia. ALL other miners and related industries, as well as banks, suggest that new coal mines may shortly become stranded assets and that expansion of the industry is ultimately unviable.

There is no question that the cheapest form of electricity is renewables. Electricity prices have risen most in fossil fuel dominated States in Australia. Gas is expensive given the high prices locked in for the foreseeable future, while coal and gas are both polluting. Integrating wind and solar into the grid can be easily managed and renewable power and storage can provide secure electricity. Carbon capture and storage is still a pipe dream worldwide, even after 10 year of research.

I urge the Government to reject this project and protect the Southern Highlands, by supporting a vision for a sustainable and coal-free future for this region.
