Dear Amber,

I refer to your email of 31 January 2018 seeking comment on the proposed section 96(1A) modification for Sydney Zoo, Western Sydney Parklands (SSD 7228 MOD 1).

I have reviewed the documents on your Department's website.

The Sydney Zoo's proposed section 96 (1A) modifications include changes to some structures and animal facilities which the Department of Primary Industries has already approved for construction under the *Exhibited Animals Protection Act 1986*. The applicant will therefore also need to apply to the Department of Primary Industries to amend these approvals.

Accordingly, it is recommended that a condition of consent be added which requires the applicant to obtain approval under the *Exhibited Animals Protection Act* for any proposed changes to structures and animal facilities that the Department of Primary Industries has already approved for construction.
