Executive Summary

This was a visual inspection only and includes a digital photographic record. This report is not to be misread as a statement of the condition of Properties surveyed, nor used for any other purpose other than as a record of the condition of the property on this date (refer special conditions above), however, it has been limited as described above. This was intended to be a brief survey highlighting obvious items and is not to be misread as an exhaustive or forensic study.

The property inspected is the entry gate, road and Council assets located adjacent to Lot 2 Forrester Road, St Marys NSW. Only damage that was noted by the inspector at the time of the inspection is indexed in this report.



General Comments

Generally only minor damage was observed with cracks noticed all over the footpath, kerb & gutter and road along Forrester Road as per the attached photos and the photos provided.

The areas inspected were only exterior parts of the train station fence/building adjacent to Lot 2 Forrester Road, St Marys NSW and the road and Council assets.

Weather at the time of the inspection was dry.














