## Australian Technology Park - Building 3 - Acoustic Statement for S96

Renzo Tonin & Associates was engaged to prepare a noise and vibration report (ref: *TH615-02F03 (r6) DA NV report*, dated: *16 December 2015*) in support of SSD 7317 for the redevelopment of Lots 8, 9 and 12 (DP 1136859) of the Australian Technology Park, Eveleigh. This letter has been prepared to support the lodgement of Section 96 application for Building 3 (Lot 8 DP 1136859) of the redevelopment.

The report prepared in support of SSD 7317 concluded:

- Operational noise could be managed and mitigated in accordance with the relevant NSW policy and guidelines set out by the NSW Department of Planning and Environment, subject to the detailed design aspects of mechanical plant and equipment;
- Noise impact upon the building from sources such as local road traffic and rail could be mitigated in accordance with the NSW policy and guidelines set out by the NSW Department of Planning and Environment; and
- Construction noise could be managed and mitigated in accordance with the relevant NSW policy and guidelines set out by the NSW Department of Planning and Environment. Renzo Tonin & Associates has prepared a construction noise and vibration management plan for the site (ref: TH615-03F02 CNVMP (r5), dated: 17 January 2017).

Design amendments resulting from the design development for Building 3 are illustrated on the architectural drawings, referenced in Table 1 below, include changes to the internal layouts and addition of a rooftop community space.

Renzo Tonin & Associates has reviewed the proposed amendments to be submitted for Section 96 application and confirm that the conclusions reached within our original report remain unaltered.
