OEH's Recommendations

Eagleton Hard Rock Quarry (Barleigh Ranch Way, Eagleton)

OEH's detailed comments

The Response to Submissions Report adequately addresses OEH's EIS comments on biodiversity

OEH considers that the Response to Submission Document has adequately addressed OEH's Environmental Impact Statement (EIS) comments with respect to biodiversity matters. As such OEH has no further comment on these matters.

OEH is satisfied with this Biodiversity Assessment Report (BAR), which was included as an appendix of the EIS, was undertaken in accordance with Framework for Biodiversity Assessment and by a person accredited in accordance with s142B(1)(c) of the repealed *Threatened Species Conservation Act 1995*. OEH recommends that the details of the Biodiversity Offset Strategy provided in the BAR should be adopted within the consent conditions for the project.

Recommendation

OEH is satisfied with the modifications to the Aboriginal cultural heritage assessment

OEH has reviewed the Aboriginal cultural heritage component of the response to submissions and notes that all Aboriginal heritage assessment components have now been adequately completed. Specifically:

- The Aboriginal cultural heritage assessment provided to support the proposed development now meets the requirements of the DECCW 2011 Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in NSW;
- The Aboriginal consultation has now been undertaken in accordance with the provisions of the DECCW 2010 Aboriginal Cultural Heritage Consultation Requirements for Proponents;
- Appropriate management strategies and consultation with the Registered Aboriginal parties
 with respect to potential investigations of the registered Potential Archaeological Deposit
 (PAD 1) have now been detailed. OEH considers that these management strategies are in
 line with the DECC 2010 Code of Practise for Archaeological Investigation of Aboriginal
 Objects in NSW.
- An updated field survey for the identification of Aboriginal cultural and scientific significance
 has now been undertaken (11 May 2017), and the results have been adequately documented
 in the updated Aboriginal cultural heritage assessment.

Recommendation

6. OEH is satisfied with the modifications to the Aboriginal cultural heritage assessment and no further changes are required.
