Please find following comments from RMS:

- Additional facilities should be provided to ensure pedestrians can safely traverse the driveway to access the crossing at Bathurst Street/ Western Distributor.
- A Dock/Loading Management Plan and a porte cochere management plan is to be submitted prior to the issue of a Construction Certificate.
- The performance of the two intersections of Shelley St/ Erskine Street and Erskine Street/ Sussex Street should be assessed as part of the Traffic Impact Assessment. These two intersections are frequently congested during peak hours and the additional traffic generated by this development is likely to exacerbate traffic queues on Shelley Street, Erskine Street and Sussex Street.
- As several construction projects are currently occurring or planned in the CBD over the coming years, the Construction Management Plan will be further discussed and refined with the developer, RMS and the CBD Coordination Office prior to the issue of a construction certificate.
