Response

This Credit Interpretation Request is approved.

For two issues identified by the project team under the Sustainable Transport Credit (17B) Prescriptive Pathway, the GBCA confirms the following:

- 1. The GBCA clarifies that under the current Design & As Built v1.1 Submission Guidelines, one point may be awarded where the project demonstrates compliance with the following guidelines (as per the requirements for Class 3 buildings)
- Secure bicycle parking for regular occupants is provided for 7.5% of total regular occupants, with associated end-of-trip facilities.
- Secure bicycle parking for visitors is provided for 5% of peak visitors.

As Stated in the Design & As Built v1.1 Submission guidelines (page 161): For buildings other than Class 2,the number of visitors to the building is determined by the project team.

Accordingly, the GBCA confirms that the project's exclusion of hotel and serviced apartment guests from the '5% of visitors' figure is an acceptable approach, provided the number of visitors used is adequately justified and documented in the submission for this credit.

1. As per the Design & As Built v1.1 Submission guidelines (page 161):

Facilities can be provided within the building's boundary, or outside. If the facilities are outside the site boundary, they must be under the control of the building owner.

Therefore, the GBCA confirms that the project team's approach conforms with the guidelines for this credit. The project team is reminded that they will be required to demonstrate these facilities will be specifically serving the project, or if shared, that appropriate apportioning is implemented.
