Part of item 149L will be removed for the construction of pod B and the Restaurant building. The rustic stone retaining walls west of the stair (139L) will be removed as part of the proposal and the garden bed excavated for the Restaurant building. No original edges remain to this garden bed. The rows of seats at the base and balustrade at the top were removed in the past. Two stonework walls remain in the garden bed with modern plantings. The section retained east of stair is in poor condition. Mitigating measures recommended later in this document. There may be an opportunity to reinstate some of the walling on each side of the new restaurant building.

The original and early paths throughout the Zoo are listed as 99L. Most existing paths/roads in the proposal site are to be removed. Some of these paths are mapped as part of 99L however most sections of the remaining paths in this area are already altered. Some paths eg near current toilet block, shown as original are not as detailed in the history and description sections of this report..

The curved path, part of 99L, adjacent the Taronga Centre will be retained, with the outer kerb on the line of the original path, with the exception of a section that will be completely excavated to a lower level and built over for the Restaurant. East of the restaurant the path and stair will be retained. There is a negative impact where Restaurant building interrupts line of path.

In another section of path mapped as part of 99L, the service road below the 1968 Platypus House, the route will be developed with a new curving entry and new paving reinstating public use. No original fabric remains in this section of path. There is no change to the paths to the north and west of the Guest Lodge.

A small section of early bitumen path above 152L will be removed and parts of the early roads near 32B (Jungle Cats) will be covered over or altered but these paths are not shown in the CS map of this item (they are on the LMP map).

The following chart sets out the heritage impacts in detail.

4.7 Impact of Proposal on Potential Archaeological Features

As the subject area has been assessed as being unlikely to contain any Aboriginal archaeological material, the proposed works would have no impact on Aboriginal archaeological resources.

The development area is an area zoned as having medium to low potential for subsurface historical archaeological evidence with a small area of original path of high significance. It is established in this report however that the section of original path identified in the AMP in this area has in fact been altered.

There is medium archaeological potential in the Wollemi lawn and expected features include remains of the Athol Quarantine Station (research has indicated these are in the Wollemi lawn not as shown in the AMP) (and possibly the associated tramline) and remains of the footings of the Ladies and Gents toilets. The Quarantine Station area is unlikely to be disturbed by the current plan but the toilet footings, if they remain, are likely to be disturbed for the footings of Pods D & E.

There may be remains of other previous construction as indicated on figures 3.5 & 3.6 but this is unlikely as the area of the former rockery is heavily altered and regraded. All the demolished stairs would have been largely above ground and are not evident.

The surviving above ground features have been identified in the Section 170 Register and the impact is assessed in the chart below.

Mitigative measures have been proposed in case of unexpected finds.

5.0 Mitigative Measures

5.1 Preamble

As elaborated in the Conservation Strategy, the zoo is a cultural landscape, the conservation of which should extend to the total resource, including the site's landscape, built elements, views and vistas, records, memories and associations, along with uses and activities.

Generally, the Zoo's site-wide values are retained ensuring the distinctive historic character of the place is retained. There is an overall question of whether the accommodation use is compatible however there are successful and popular precedents elsewhere in the Zoo and the proposal has potential to bring increased visitation and provide income to assist the ongoing conservation and educational aims.

The proposal removes and alters some individual heritage items. The Australian Section 2 exhibit, part of item 123L is removed. The kiosk roof and columns are removed and relocated on a new base and the existing base demolished. This reveals the original fountain under. A semicircular wall is built on the part of the fountain on the exterior of the building and the fountain wall on the interior and the central plinth are demolished.

Identified heritage significant trees are retained and other mature trees. Significant new planting is proposed of local species. Two identified plants are removed. Views are not impacted. There are possible archaeological remains in the Wollemi lawn area.

The following recommendations are made by way of mitigative measures.

5.2 Detail of Mitigative Measures

Detailed Design

Detailed design is needed to resolve the interface between the proposal and heritage items in the site including the fountain and shelter, the path and retaining walls adjacent the Taronga Centre and adjacent the former "Big Cats" 32B, the rock walls of garden bed 149L, the new aviary with the Brown Pine (169L), retaining wall 152L and the exhibit fence and the plantings and movable items in the Wollemi Lawns.

Detailed design should minimise deleterious impacts on these heritage items. The detailed design should retain as much as possible of the fountain, particularly the circular edge. The design needs to consider minimising impact on the remaining masonry stair and the masonry and stone seats and on vegetation within the site and items in the vicinity. If possible more of item 149L should be retained (or re-established after construction). The design of the new base for the kiosk/shelter should use authentic details developed by research and physical investigation of the existing. Designers should liaise with the Zoo's heritage advisor, currently Jean Rice, Senior Project Manager, Heritage.

Conservation Works

Conservation works should be undertaken to items affected by the works including the masonry stairs, stone retaining walls and garden walls and the kiosk roof and columns.

Conservation Advice

Appropriate conservation advice should be available during the detailed design phase and throughout the works program. This should include availability for response to unforseen circumstances that may arise during construction. Currently regular heritage advice is being provided to Taronga Zoo by staff specialist, Jean Rice, Senior Project Manager, Heritage.

Archival Recording

The history of the site is generally documented and additional research has been undertaken in respect to this project. A photographic archival record should be made of the proposed site and items in the vicinity including individual heritage items, their respective settings and views to and from the subject development area. Additional recording should be made during the works, paying attention to any items revealed during excavation and tree removal. In particular the stone walls in garden bed 149L should be recorded after the removal of the trees. The tree removal should not damage the stone garden retaining walls. Recording should also be made of the removal of the shelter and its columns, the fountain after removal and adjacent excavation and of Australian Section 2 before its removal.

Archaeology

Approval from the Heritage Council of NSW under Section 140 of the *Heritage Act 1977* (NSW) is only required if archaeological remains are to be impacted upon, in accordance with the policies and recommendations outlined in the Taronga Zoo AMP. It appears that the fabric or the original paths and stairs has been removed in the past. There may be remains of the toilet blocks below Pods D & E and remains of the Athol Quarantine Station in the Wollemi Lawn. This may be impacted by works in the area including the relocation of the shelter. Additional research and documentation is needed to determine if there will be an impact. If there is a permit should be applied for and excavation undertaken by an archaeologist.

Contractor Induction

Suitable clauses should be included in all site contractor and subcontractor contracts to ensure that on-site personnel are aware of their obligations and requirements in relation to the *Heritage Act 1977* (NSW). Specifically, relevant on-site personnel should be made aware of the procedure to be followed for notification and stopping works should items of heritage significance be found during site works.

Unexpected Remains

In the event of unexpected historical archaeological relics are encountered during site works, works will cease immediately and the NSW Heritage Office notified, pursuant to Section 146 of the Heritage Act 1977 (NSW).

Interpretation

An important obligation arising from the historic significance of Taronga Zoo is that its cultural heritage values should be interpreted to the public. Previous studies have recommended that a strategy for interpreting the site as a whole should be developed to effectively and creatively incorporate an integrated approach to interpreting the site's significant heritage aspects but this has not yet been done.

In this case there should be interpretation of the demolished Australian section 2, the former fountain base and the relocated shelter and their relationship. There should also be interpretation of the former rockeries with the removal of the remnant 149L.

The former circular path edge and line of the former balustrade adjacent to the Taronga Centre should be interpreted in the new landscape design in paving or a low wall or similar.

Protection of Heritage Items during Works

Adequate signage should be erected in the vicinity of the heritage items within the development site that are to be retained alerting contractors and subcontractors to their existence and fragile nature. The stone seats should be carefully protected – for example by solid structural protective covers.

Stone from the removal of items 149L should be stockpiled for later reinstatement or for future use in repairing landscape elements including the eastern part of 149L.

Temporary access to the site should be determined in such a manner so that there is no impact of the surrounding heritage items, vegetation or landforms.

Landscape Heritage Items

The existing landscape heritage items in the precinct and within its vicinity are to be clearly marked and all workers inducted as to their significance prior to starting works on the site.

All works to significant trees should be undertaken in accordance with the Taronga Zoo Tree Protection Guidelines.

The wisteria and murraya are listed but are proposed to be removed. Similar species should be planted at a suitable location such as site of relocated shelter or elsewhere in public spaces within the Zoo.

The boundary plantings are retained but some trees in the boundary plantings are not healthy and will eventually require succession planting.

If overshadowing or the kangaroos affect the tree gardenia's viability succession planting should be undertaken in a suitable nearby location preferably taking cuttings from the existing tree.

6.0 Conclusion

The primary significance of Taronga Zoo lies in its unique and evocative cultural landscape; the place's ability to show the evolution of zoological approaches over the last century; its continuity of use and its recognition as a zoo of world-standing; and for the iconic sense of place and esteem in which it is held by visitors and Sydney residents.

Negative impacts on individual items should be mitigated by relocation, conservation of remaining elements and interpretation of items removed. The gradual removal of minor elements risks loss of values through incremental change.

The proposal provides a compliant equitable access route to and within the site, which is not currently the case. The ramped path in the Wollemi lawns also provides general public equitable access to the Wollemi Exhibit.

The design of the relocated shelter roof and columns needs to be carefully developed to preserve its heritage value and authenticity. The design of the foyer around the fountain base needs to retain as much original fabric as possible and to enable visitors to understand that it was a circular fountain.

Overall, the proposal generally satisfies the objectives of the Conservation Strategy, Archaeological Management Plan and Landscape Management Plan and has an overall neutral heritage impact on the place as a whole, while facilitating Taronga's ongoing role as a Zoo of world-class standing.
