Attention Kelly Mc Nicol Team Leader Industry Assessments.

Dear Madam

I am in receipt of the amending development application submitted by Arcadis Australia on behalf of Bingo Recycling Pty Ltd located at 13 Pembury Road Minto 2566 NSW.

The original development application submitted by Bingo was objected to by a number of property owners of property located in Pembury Road Minto.

The current amending application provides no more technical support for the amending application than the original amending submission.

I object to the development

The amended submission was to increase resource recovery from 30,000 tonnes per year to 220 000 tonnes per year.

To support their amended application, Bingo have engaged a company called Arcadis Australia to prepare the amending application documentation, based on the traffic flow of traffic using Pembury Road Minto during proposed working hours.

As stated previously there are a number of National Transport Companies that also have facilities located in Pembury Road Minto that also impact on the road use of Pembury Road.

In addition they also have provided details of the types and size of vehicles using Pembury road Bingo facilities . Unfortunately the amended submission the user numbers do not add up as they have no control over the size and type of vehicle currently being unloaded or provide visitor parking.

We often have Bingo staff parking on our front lawn and when challenged they answer by claiming that Bingo have instructed staff to park on our lawn.

The company claims they are going to provide an unloading stacking facility for 17 vehicles with the largest size vehicle to be stacked is a 26 meter long "B" double with a load capacity of 65 tonnes. That equates to an area of 52 meters long 2,50 meters wide and 14 meters high.

That means that to load and unload the stacked loaded trucks would also require a significant space for the movement of the vehicles during un loading.

It is obvious, that making operational instructions that they then must be put into operation.

The amending application does not identify the number and type of large machinery that is required to operate on the floor, has safety been taken care of.?

It's all right stating the operation but you also need to take into account the fellow workers required to safely operate and inspect the recycled material.

Unfortunately this amending application prepared by Arcadis Australia does not change the application from that previously submitted, and rejected,
