

The acoustic assessment has been undertaken to ensure compliance at all surrounding residential receivers including the following:

- 1. Residences approximately 405m to the West of the site located at 1489 The Horsley Drive.
- 2. The noise impact assessment has been undertaken to the residential receiver to the north of the site at 2614 Cowpasture Road, Horsey Park, as detailed in the figure below.



The recommended acoustic treatments and controls within the Noise and Vibration Impact Assessment (Ref: 20160482.1/0704A/R1/BW) include those required to ensure all noise levels at surrounding receivers comply with the relevant criteria, including the residential receiver at 2614 Cowpasture Road, Horsey Park.

The relevant noise level criteria at the residential receivers includes the following:

Noise criteria for the day has been based off the INP intrusiveness criteria and the evening and night have been assessed against the amenity criteria. Based on the assessment noise levels will comply with the relevant noise level criteria at all surrounding receivers including 1489 The Horsley Drive and 2614 Cowpasture Road, Horsey Park.
