

Good morning Peter, Joel, Tony & Michael

Further to my email below and responding to the City Of Sydney's concerns raised in response to the projects RTS(copy attached), Root Partnerships and the consultant team have further reviewed and developed flooding data. Updated advice confirms flood levels with removal of a sandstone plinth off Chalmers st, adjacent to the driveway entry to the park, will bring the flood level 20mm below the floor level on Chalmers Street that is at most threat of inundation. Provided in the below link is the consolidated Flooding data demonstrating the modelling conducted and a summary of our findings.

We understand through our consultation with the various City of Sydney departments, that the removal of this plinth will be an acceptable mitigation measure. We therefore provide plans in the below link for your consideration showing our proposed alterations to this entry. Finer details of this design and its construction to be resolved through detailed design documents at a later date.
