beams that restrain the folded beams supporting the Monumental Steps and

#### PROPOSED WORKS

2. All significant structures, fabric and elements must be protected during the works from potential damage. All tradespeople and workers on site be made aware of the significant fabric on site and the works overseen by a heritage architect appropriately qualified and experienced in working with similar structures, methods and materials.

Reason: To ensure significant fabric is not impacted during the works.

#### HERITAGE CONSULTANT

3. A suitably qualified and experienced heritage consultant must be nominated for this project. The nominated heritage consultant must provide input into the detailed design, provide heritage information to be imparted to all tradespeople during site inductions, and oversee the works to minimise impacts to heritage values. The nominated heritage consultant must be involved in the selection of appropriate tradespersons, and must be satisfied that all work has been carried out in accordance with the conditions of this consent.

Reason: To ensure that appropriate heritage advice is provided to support best practice conservation and ensure works are undertaken in accordance with this approval.

## **SPECIALIST TRADESPERSONS**

4. All work to, or affecting, significant fabric shall be carried out by suitably qualified tradespersons with practical experience in conservation and restoration of similar heritage structures, materials and construction methods.

Reason: To ensure that any demolition, construction, conservation and repair of significant fabric follows best heritage practice.

### **COMPLIANCE**

5. If requested, the Applicant and nominated Heritage Consultant may be required to participate in audits of Heritage Council approvals to confirm compliance with conditions of consent.

Reason: To ensure completion of the works in accordance with the approved plans and to improve the approvals process through a better understanding of the implementation of conditions of approval.
