# Mixed Use Residential and Commercial Development, 21 Honeysuckle Drive, Newcastle (SSD 8019) Request for Secretary's Environmental Assessment Requirements

I refer to your email of 21 October 2016 to the Department of Primary Industries (DPI) in respect to the above matter. Comment has been sought from relevant divisions of DPI. Views were also sought from NSW Department of Industry - Lands that are now a division of the broader Department and no longer within NSW DPI. Any further referrals to DPI can be sent by email to landuse.enquiries@dpi.nsw.gov.au.

DPI has reviewed the request and accompanying SEARs and provides the following recommendations:

- The heading of section 9 should be amended from "Water Quality" to "Water"
- The EIS should be required to address:
  - Annual volumes of surface water and groundwater proposed to be taken by the activity (including from potential seepage into the basement carpark) from each surface and groundwater source as defined by the Water Sharing Plan for the North Coast Coastal Sands Groundwater Sources 2016.
  - Detail of any structural works required to be undertaken due to potential mine subsidence impacts. This should include information regarding whether grout injection may be required and whether this activity may cause displacement of groundwater to surface.
  - Detail of any groundwater dewatering which may be required during the construction phase of the project. This discussion should include:
    - information on the site's hydrogeology;
    - a description of the current groundwater situation, such as groundwater quality and groundwater level;

- predicted groundwater take, inclusive of the calculations supporting this estimate; and
- assessment in line with the NSW Aquifer Interference Policy (2012).
- The EIS should be required to include a statement of where each element of the SEARs is addressed in the EIS (e.g. in the form of a table).

- 'The Applicant' As noted on the draft SEARs is a different entity to that which is party to the contract for sale for the subject property. That entity is Doma Holdings (NSW) Pty Ltd ACN 612 047 631;
- 'Key Issue 10' Mine Subsidence. It is important that the Applicant provides a
  geotechnical report prepared by a suitably recognised professional detailing the suitability
  of the site to support the proposal. The Hunter Development Corporation has recently
  completed mine subsidence stabilisation works in preparation for development, the
  proponent is aware of this and has been furnished with the following reports:
  - Proposed Mine Subsidence Mitigation Plan Honeysuckle, GEOTWARA20878AA-AN, Coffey Geotechnics Pty Ltd, 20 December 2010
  - Park Residential Site Cottage Creek Precinct Development Final Report Summary of Mine Stabilisation Activities, GEOTWARA22377AA-AP, Coffey Geotechnics Pty Ltd, 2 February 2016
  - The Letter from the Mine Subsidence Board dated 17 March 2016 (ref FN10-26310N1) which accepts the findings and recommendations of the above report dated 2 February 2016.

# Re: Request for Secretary's Environmental Assessment Requirements (SEARs) for a Mixed Use Development SSD 8019, No. 21 Honeysuckle Drive, Newcastle

I refer to your e-mail dated 21 October, 2016, seeking input into the Department of Planning and Environment Secretary's Environmental Assessment Requirements (SEARs) for the preparation of an Environmental Impact Assessment (EIS) for a Mixed Use Development at No. 21 Honeysuckle Drive, Newcastle

The Heritage Division has reviewed the draft SEARs and recommends the following additional requirements:

- The Environmental Impact Statement (EIS) should identify if there are any listed or potential heritage items within the proposed project area and in the vicinity. If any listed or potential heritage items are likely to be affected, a Heritage Impact Statement (HIS) must be prepared in accordance with the guidelines in the NSW Heritage Manual that addresses the significance of, and provides an assessment of the impact on the heritage significance of heritage items on the development site and in the vicinity.
- The EIS must provide a heritage assessment including but not limited to an assessment of impacts to *State and local heritage* including conservation areas, natural heritage areas, places of Aboriginal heritage value, buildings, works, relics, gardens, landscapes, views, trees should be assessed. Where impacts to State or locally significant heritage items are identified, the assessment shall:
  - outline the proposed mitigation and management measures (including measures to avoid significant impacts and an evaluation of the effectiveness of the mitigation measures) generally consistent with the NSW Heritage Manual (1996),
  - be undertaken by a suitably qualified heritage consultant(s) (note: where archaeological excavations are proposed the relevant consultant must meet the NSW Heritage Council's Excavation Director criteria),

- include a statement of heritage impact for all heritage items (including significance assessment), consider impacts including, but not limited to, vibration, demolition, archaeological disturbance, altered historical arrangements and access, landscape and vistas, and architectural noise treatment (as relevant), and
- a historical archaeological assessment prepared by a suitably qualified historical archaeologist in accordance with the Heritage Division, Office of Environment and Heritage Guidelines 'Assessing Significance for Historical Archaeological Sites and 'Relics' 2009. This assessment should identify what relics, if any, are likely to be present, assess their significance and consider the impacts from the proposal on this potential resource. Where harm is likely to occur, it is recommended that the significance of the relics be considered in determining an appropriate mitigation strategy. In the event that harm cannot be avoided in whole or part, an appropriate Research Design and Excavation Methodology should also be prepared to guide any proposed excavations.
