### SCHEDULE 1

**Consent No:** SSD 8169

**Applicant:** Billinudgel Property Pty Ltd

**Consent Authority:** Minister for Planning

**Development:** Construction and operation of the North Byron Parklands Cultural Events Site, comprising the following:

- ongoing use of the cultural events site for cultural, educational and outdoor events with ancillary camping and car parking;
- ongoing use of existing site infrastructure;
- construction and operation of additional site infrastructure to support the cultural events site; and
- construction and operation of a conference centre with associated accommodation.

**Modification:** SSD 8169 MOD 1 – Amendment to Conditions A7 and D45

1. Delete the definition for Department and Minister and insert the following definition:

The document assessing the environmental impact of a proposed modification of this consent and any other information submitted with the following modification applications made under the EP&A Act:

- SSD 8169 MOD 1 – Statement of Environmental Effects titled *North Byron Parklands Cultural Events Site (SSD 8169) – Section 4.55 Modification (MOD 1)*, prepared by PJEP Environmental Planning and dated 29 April 2019 and *North Byron Parklands Cultural Events Site – Section 4.55(1A) Modification (SSD 8169 MOD 1) – Additional Information*, prepared by PJEP Environmental Planning and dated 11 June 2019

#### **In Schedule 2: Part A – Administrative Conditions**

2. In Condition A2(e), delete the word “and” after the semicolon.
3. In Condition A2(f), delete the period after the words “Appendix 2” and replace with “; and”.
4. Insert new condition A2(g) as follows:  
  
(g) Modification Assessments
5. In Condition A7, insert the words “or the large summer event at a capacity of 30,000 patrons,” after the words “42,500 patrons,”.
6. In Condition A7, delete condition A7(a) and replace with the following:  
  
(a) the Applicant has previously held an event at the site with a capacity of:
  - i. 35,000 patrons for the large winter event; or
  - ii. 25,000 patrons for the large summer event;

#### **In Schedule 2: Part D – Conditions Relating to the Carrying Out of Events**

7. Delete Condition D45, and replace with the following:  
  
D45. Prior to the first outdoor event, the Applicant must prepare a Drinking Water Quality Assurance Program to be implemented for the life of the development. The Applicant must:
  - a) ensure the Quality Assurance Program complies with the Public Health Regulation 2012;
  - b) comply with its Quality Assurance Program;
  - c) provide a copy of the Quality Assurance Program, and any subsequent amendments, to NSW Health (North Coast Public Health Unit); and
  - d) address any feedback provided by NSW Health on its Quality Assurance Program.

A copy of the Quality Assurance Program, and any subsequent amendments, must also be submitted to the Planning Secretary.
