Newcastle City Council:

- 1. At point 9 we would like to respond with:
- "In discussions with the Port of Newcastle, Rebecca Johnson was adamant that no street tree plant was allowable on their land. Additionally, NCC's requirement for street trees is based on meeting the requirements of DCP....(please fill in correct numbers) and as stated in section 5.10 the DCP is not a matter for consideration
- At dot point 10 include in the responses "The sewer for the proposed development will be connected to te existing system that was approved and installed in Stage 1 and was designed with the knowledge of additional future users. Reference appendix's 10,11 and 12
- 3. At point 11 the reference should be to Section 3.3. We have asked you to remove the sentence re the after-hours movement but would like to have this section beefed up by dot pointing the measures i.e.
 - a. The site is to be fenced with 1800mm high colourbond security fence with 3 rows of barbed wire above.
 - b. Vehicle entry and exit to the facility is to be via Egret Street, and is to controlled by 1800mm high electrically operated palisade sliding security gate.
 - c. A personnel access gate is to be located at the office building and can only be opened by Elgas personnel issued with identity password cards.
 - d. The site will also be well lit.
 - e. Clear visibility from the road
 - f. The building will be alarmed
 - g. No cash will be kept on the premises
 - h. No stock of any great value
 - i. After hours security patrol
- 4. At point 12 you have referenced Appendix 18 which should be the QS report at the moment Appendix 18 is the "AHIMS Search"
- 5. Points 10, 11 and 12 need to have their response aligned to their responses.

Port of Newcastle: Phone call by Mitchell Sovechles to Rebecca Johnson on Friday 14/7 re the development issues raised by PON letter to the SEARs. There were two points discussed;

- 1. The Stormwater system has been designed to accommodate the stormwater from all of Lot1. The design was submitted with the previously accepted and approved service station, food outlet and carwash. There will be further information in the EIS which can be reviewed.
- 2. Rebecca is satisfied with the proposed landscape design as it was a continuation of what has been previous approved and installed. She also made comment that PON did not want to see street tree planting.
