Certificate of Investment Value

As requested we have prepared this Quantity Surveyor's Certificate of Cost to verify the Capital Investment Value of the project in accordance with the definition contained in the State Environment Planning Policy (State Significant Precincts) 2005.

Under this policy the Capital Investment Value has the same meaning as in the Environmental Planning Assessment Regulation 2000 which was amended on 7 May 2010 to the following;

Capital Investment Value of a development or project includes all costs necessary to establish and operate the project, including the design and construction of buildings, structures, associated infrastructure and fixed or mobile plant and equipment, other than the following costs:

- (a) amounts payable, or the cost of land dedicated or any other benefit provided, under a condition imposed under Division 6 or 6A or Part 4 of the Environmental Planning and Assessment Act or a planning agreement under that division
- (b) costs relating to any part of the development or project that is the subject of a separate development consent or project approval
- (c) land costs (including any costs of marketing and selling land)
- (d) GST (within the meaning of A New Tax System (Goods and Services Tax) Act 1999 of the Commonwealth)

Based on this definition, we advise that our estimate of Capital Investment Value for the proposed early works is \$48,440,000 (excluding GST).



This is broken down as follows:

Construction \$ 46,130,000 \$ 2,310,000 Design

Total \$ 48,440,000

We note the estimate excludes allowances for the following items based on advice provided by the NSW Department of Planning;

- Development Application and Demolition Certificate fees
- Authority fees
- Finance costs
- Escalation for potential cost increases beyond November 2017
