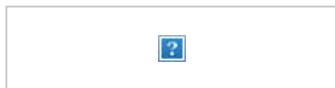
Thank you for the opportunity to comment on the proposed modification 3 of SSD 8517 to Bays 3-4A Locomotive Workshops relating to minor amendments to the base build layout on the ground floor level, to the approved supermarket layout.

The modification includes insertion of an additional egress stair, amendment to the GFA, removal of signage zones, amendments to description of development and Condition A2, and a store room behind the loading dock to the Bay 3 North for temporary storage and to handle delivery material from the trucks. Overall, the proposed alterations do not significantly change the approved layout and are not likely to have significant impact on the heritage fabric or transport/traffic impacts.

Council have reviewed the documentation submitted with the application and wish to make no comment on the proposed minor amendments.
