## Re: Biodiversity Offset Credits for the Suntop Solar Farm

Dear Nicole.

As I am sure you are aware, Canadian Solar are progressing well with the construction of Suntop Solar Farm.

Condition 13 of Schedule 3 of the development consent required that Canadian Solar retire the required biodiversity credits through the market and/or pay residual obligations to the Biodiversity Conservation Fund. On 29 July 2020 Canadian Solar requested an extension to the deadline which was approved by the Department in a letter dated 14 August 2020. The deadline was extended to 31 May 2021.

We can confirm that on 17 May 2021, Suntop SF Pty Ltd (as trustee for Suntop Asset Trust) acquired the required credits under transaction number CR-7324 and on 25 May 2021, these credits were retired under transaction number CR-7398.

The BCT have informed us that unfortunately due to technical difficulties, they are not able to provide a formal letter to confirm but have provided us with email confirmation. Please see attached emails confirming the transfer and retirement of the required credits as well as a copy of the most recent *BOAM Credit Transaction Sale Export* document from the BCT website as confirmation.

We believe that condition 13 of Schedule 3 of the development consent has been met and all Biodiversity Offset requirements have now been satisfied.
