

The Sandigo Solar Farm is a utility scale renewable energy project with an output measuring up to 100 megawatts (MW) that will generate clean and renewable electricity from the power of the sun. The project will generate enough electricity to power the equivalent of approximately 160,000 homes.

The \$85 million dollar project is located southeast of the township of Narrandera in the Narrandera Shire Council. The project site was chosen due to its proximity to Trangrid's transmission network, access from the Sturt highway and relatively flat land.

The solar farm will comprise of up to 300,000 solar photovoltaic modules, known more commonly as 'solar panels'. The solar panels are identical in type but larger in size to those used in residential solar installations installed on homes throughout Australia.

The solar panels will be installed on ground-mounted frames that will slowly track the daily horizontal movement of the sun. The solar panels will generate direct current ('DC') electricity that will be inverted to alternating current ('AC') via power conversion units. The power conversion units located within the site will feed AC electricity into an onsite power reticulation system before the power is centrally collected and dispatched to the local electricity distribution network via the Transgrid transmission network.




