1. Introduction

This Operational Management Plan has been prepared by Impact Group on behalf of the

Presbyterian Church (New South Wales) Property Trust for the major alterations and

additions to the Stevenson Library Building at The Scots College, Bellevue Hill. This report

is provided in support of the submission of the Environmental Impact Statement and the

Development Application to the Department of Planning and Environment.

The Operational Management Plan provides details of the school operations during

construction and the adaptation of the operations during construction.

2. The School

The Scots College is a private day and boarding school for boys from Kindergarten to year

12. Located on Victoria Road, Bellevue Hill. The current core school hours are from

8:25am to 3:05pm with no requirement for before or after school care at the upper campus

where the development will be undertaken.

The current school population is as follows:

Total School population: 1504 students

Boarding capacity: 225 students

Day Students: 1279 students

Staff: 320 full time equivalent permanent staff members and 300 casual staff

The works associated with the major alterations and additions to the Stevenson Library

will include the following:

Site establishment including site accommodation, hoarding, temporary services,

environmental controls and the establishment of a work zone around the work area

Removal of existing plant

Remove existing services

Strip out of the existing library building

Removal of the metal deck roof

- · Removal of all internal walls
- Removal of the external building fabric
- Construction of internal walls and partitions to suit the designed layout
- Construction of the external fabric per the design
- Installation of services
- · Construction of amenities as designed
- Installation of lifts
- Possible increase in the existing services infrastructure

In undertaking the project, there is no proposal to increase any staff or student numbers due to this. In addition, there is currently no proposal to offer the amenities for general public use. It is acknowledged, however, that there will be access and use of the facility outside of teaching hours through the various College support groups and associations such as the Old Boys Union, the Women's Association, the Parents Association and other support groups and associations.



3. Works Impact

In undertaking the works, it is acknowledged that the school will remain operational during the programme of works. In addition, it is further acknowledged that there will be student displacement during the period of construction. This displacement amounts to the following:

- Seven classrooms
- Library
- Campus cafeteria
- Offices
- Senior studies area

In order to accommodate the reduction in space, the College has advised that this will be accommodated in existing College building, through timetable consolidation, and through the adaptive reuse of two open hall spaces, with no intention to utilize temporary demountable buildings. It is through these initiatives that continuity of the education process will be achieved.

In addition to the above, the current Library building is located within the school campus, and is able to be isolated through temporary hoarding. The isolation of this area will have minor impact on the campus amenity, with particular reference to the sporting oval. Any sporting activities that will be impacted will be accommodated elsewhere.
