Dear Cameron,

The new Sydney Fish Market Main Works SSD-8925 Modification 2 – Administration Error

I am writing to you to apply to modify the consent to SSD-8925 approved by the Minister for Planning and Public Places on 12 June 2020 for the construction, use and operation of the new Sydney Fish Market at Blackwattle Bay.

INSW seek to modify this consent in accordance with the provisions of Section 4.55(1) of the Environmental Planning and Assessment Act 1979 (EP&A Act).

The modification application seeks to amend condition B52 of the consent as Transport for NSW (TfNSW) have confirmed they are unable to provide approval for the marine structures and construction vessel traffic management plan. Similarly, INSW are requesting amendment of condition B54 to align with SSD-8924 (Concept and Early Works). Further details on the justification for the amendment are contained below. The application seeks to correct these minor errors.

Condition B52 – Marine Structures

INSW are requesting for Condition B52 to be modified:

MARINE STRUCTURES

- B52. Prior to the issue of the relevant Crown Building Works Certificate, the detailed design of all marine structures (public pier, waterfront promenade, wharve structures and pontoons) must be submitted to and approved by TfNSW (Maritime). The drawings and specifications are to:
- a) Comply with NSW Maritime's Engineering Standards for Maritime Structures and NSW Maritime's Guidance Note Documentation, AS 4997-2005 Guidelines for the Design of Maritime Structures and AS 3962-2001 Guidelines for Design of Marinas;
- b) Fully and clearly describe all new works for land below the Mean High-Water Mark and all their components and interconnections;

- c) Demonstrate the structural components have been designed by a practising structural Civil Engineer and experienced in the design of maritime structures;
- d) Include all marine ecological aspects and initiatives within the Marine Ecological Assessment prepared by Ecological Australia dated 2 April 2019, so opportunities to increase marine biology are realised.
- e) Include all management and mitigation measures within the Navigation Impact Assessment prepared by Royal HaskoningDHV, dated 20 September 2019.

As per correspondence in Appendix A, TfNSW has confirmed that they can only provide acknowledgement that they have received all the relevant documentation and certifications under condition B52.TfNSW cannot approve any design engineer plan.

INSW request for the condition to be amended from "shall be submitted to and approved by TfNSW (Maritime)" to "shall be submitted to the satisfaction of TfNSW (Maritime)"

Condition B54 – Construction Vessel Traffic Management Plan

INSW are requesting for Condition B54 to be modified:

CONSTRUCTION VESSEL TRAFFIC MANAGEMENT PLAN

B54. Prior to the commencement of works, a Construction Vessel Traffic Management Plan (CVTMP) prepared by a suitably qualified person shall be submitted to and approved by TfNSW (Maritime) and Port Authority of NSW. The CVTMP must include the management and mitigation measures outlined in the Navigation Impact Assessment prepared by Royal HaskoningDHV, dated 20 September 2019. A copy of the CVTMP must be provided to the Planning Secretary.

As per correspondence in Appendix B, TfNSW has confirmed they would like to align condition B54 of SSD-8925 to B34 of SSD-8924 (Concept and Early Works).

INSW request for the condition to be amended from "shall be submitted to and approved by TfNSW (Maritime)" to "shall be submitted to the satisfaction of TfNSW (Maritime)".

Conclusion

There are no expected impacts of the modification to the consent to SSDA-8925 as it is to correct a minor error and the development will remain substantially the same development as that originally approved. The proposed modification is considered to be in the public interest.

I just want to double check on the approval of the VTMP.

The proposed wording change to 'shall be submitted to the satisfaction' is in line with the Early works condition for the VTMP (Condition B34). DPIE flagged that they may have accidently put the wrong wording in the main works condition. So we are surprised TfNSW wants different wording in the Main works condition. Following on from your below email, it is required for INSW to go through a modification process through the Department of Planning, Industry and Environment to amend the wording of Condition B52 *Marine Structures* so TfNSW will not need to approve the detailed design of the marine structures.

Before we submit the modification I wanted to bring to your attention Condition B54 which requires for TfNSW to approve the Construction Vessel Traffic Management Plan (CVTMP):

CONSTRUCTION VESSEL TRAFFIC MANAGEMENT PLAN

B54. Prior to the commencement of works, a Construction Vessel Traffic Management Plan (CVTMP) prepared by a suitably qualified person shall be submitted to and approved by TfNSW (Maritime) and Port Authority of NSW.
