The Mulwala Solar Farm is a utility scale renewable energy project with an output measuring up to 140 megawatts (MW) that will generate clean and renewable electricity from the power of the sun. The project will generate enough electricity to power the equivalent of approximately 65,000 homes.

The \$130 million dollar project is located north of the township of Mulwala in the Federation Council. The project site was chosen due to its proximity to Essential Energy's Mulwala Substation, lack of environmental constraints, and flat land.

The solar farm will comprise of up to 400,000 solar photovoltaic modules, known more commonly as 'solar panels'. The solar panels are identical in type but larger in size to those used in residential solar installations installed on homes throughout Australia.

The solar panels will be installed on ground-mounted frames that will slowly track the daily horizontal movement of the sun. The solar panels will generate direct current ('DC') electricity that will be inverted to alternating current ('AC') via power conversion units. The power conversion units located within the site will feed AC electricity into an onsite power reticulation system before the power is centrally collected and dispatched to the local electricity distribution network via the Essential Energy transmission network.

### **ESCO Pacific Overview**

- Leading Australian developer of ground mounted utility scale solar farms
  - Over 1,500 MW of solar development sites secured in QLD, NSW and VIC






### A suitable site

#### The Mulwala Solar Farm proposal:

- Close to Essential Energy Mulwala Substation (picture)
- Flat land: Visual impact can be addressed with vegetation screening

### **Utility-scale solar farms:**

- No noise audible from neighbouring properties during operation
- Impacts on impermeable surfaces are negligible
- No concrete foundation: no impact on water tables





### **Economic stimulus**

- \$130M regionally significant project approx. \$20-25M to be invested in the region subcontractors, labour, equipment
- Additional regional visitation resulting in flow on benefits for hotels, shops, restaurants and other local service providers
- Supports ongoing diversification of employment, services & skilled labour pool
- Over 150 jobs during construction, 2-3 full time highly skilled jobs during operation and several on-going contracts
- Engagement with local chamber of commerce, council, higher education organisations and job centres to upskill workforce

### Community Engagement

- Project introduction with NSW Department of Planning and Environment and Federation Council Planner in December 2017
- First contacts with immediate neighbours (including Housing Estate developer) undertaken in December
- Project presentation to Federation Council (Corowa) in January 2018
- Aboriginal consultation January to May 2018
- Community session April 2018
- Follow up of specific neighbour issues and concerns
- Design to minimise impacts to neighbours setback, landscaping etc
- Potential impacts on immediate neighbours will be managed, mitigated wherever possible, including transport delays, noise, dust and visual appearance.



## Design modifications through consultation



- The solar farm has been designed to minimise impacts to neighbours and environmental constraints. These include:
  - Setback from patches of native vegetation
  - Access via safe intersection and sealed road whenever possible (Savernake Road)
  - Landscape screening
