Hi Jack.

I have finalised the hazard and risk review for the abovementioned development.

The development, if approved, would consist of:

- ground-mounted photovoltaic solar array;
- battery storage;
- substation; and
- associated with the development infrastructure, office, operations and maintenance buildings.

In the context of SEPP 33, the main hazard associated with the above development is the battery storage. The total capacity of the battery storage is proposed to be approximately 144MWh/101 MW. The proposal would comprise lithium-ion batteries housed across the site in up to 30 customised containers with inverters. The capacity of each container is estimated to be 4.8MWh/3.36MW (based on using Samsung-Sungrow Li-ion battery pack). The EIS considers the application of SEPP 33 to the proposed battery storage and based on the storage configuration and the capacity of a single container, concludes that the proposal is not potentially hazardous and therefore a PHA is not required. Nevertheless, the potential fire hazards of the batteries is recognised and a number of control measures are listed in the EIS to minimise the potential for an incident.

Based on the information provided in the EIS, and assuming all control measures listed in the EIS will be implemented and maintained, the Department concludes that potential for harm from the development is insignificant and further assessment of the risk is not warranted. To ensure the development will be designed, built and operated safely, the control measures listed in the EIS should be implemented and maintained.
