I object to the proposal and the process.

#### 1. The decision to redevelop the Sydney Football Stadium

The Government should be asking why those responsible for appalling governance of an important State asset should retain their positions. Instead it is rewarding the Trust by giving them a new Stadium. This is setting a poor example for those responsible for the governance of other major State assets.

#### 2. The SFS - Where to from here?

I am concerned at what seems to be a compression of the development timeline in an effort to get the project so far advanced by early 2019 that an incoming Labor Government would be unable to reverse it. How can the community's views on the Stage 1 EIS be fully taken into account in the tendering process if the timeline is not aligned to facilitate this?

#### 3. Opportunities for Public Input

There is no provision for a Community Consultative Committee during Stage 1 of the SFS redevelopment. We're concerned this decision has been driven by administrative convenience rather than the needs of the community. This project is highly complex and has potentially major impacts on many residents and Moore Park.

In 2016, the SCG Trust established the Trust Advisory Group (TAG) for the local community "to provide feedback and advice on current and future plans for the SCG precinct". However, the Trust excluded the TAG from the schedule of briefings INSW has had with various interested parties. Some people may conclude from this that the TAG exists for 'window-dressing purposes' rather than as a genuine vehicle for community consultation.

#### 4. Impact of new SFS on Moore Park

I understand the budget for the new stadium doesn't include funds for integration with Moore Park after construction. Issues include parking arrangements and pedestrian access and dispersal planning, lighting and signage. There are also broader impacts - such as traffic management planning, managing the impact of increased crowds on the local community and the impact on nearby commercial operations in the EQ, Fox Studios, etc.

#### 5. Funding for Moore Park

Although the City of Sydney is not the consent authority, it appears the State Government may be proposing to make a substantial contribution to it because of "the demand for public amenities and public services within the area" arising from the SFS redevelopment. While some payment to the City of Sydney may be appropriate, this will be a wasted opportunity for the Government to allocate significant funds for the remediation and upgrading of Moore Park. I therefore call on the Government to make a sizeable development contribution to the Centennial Park & Moore Park Trust for use in progressing the Moore Park Master Plan.

#### 6. Future of Driver Avenue

if the new stadium proceeds, and follows best practice design principles, there will be no need to close Driver Avenue for safety and security reasons.

#### 7. New Building on existing SCG land

The SCG Trust plans involve a new five or six story building on the members carpark, next door to the Rugby Australia/UTS building. It has declined to provide an assurance that it will not use the exemptions under its Act, and that any new building proposal will be subject to a formal DA/EIS process that is no less extensive and thorough than that being used by INSW for the stadium redevelopment. It's untenable that two major construction projects will be progressed side by side under two completely different sets of rules.

This project appears to lack appropriate need, planning, consultation and transparency.

I am objecting to the proposed Sydney Football Stadium redevelopment. The stadium plans are an unjustified and a waste of nearly \$700 million of public money. The Government made its decision without sufficient consultation with the local community and without considering all impacts, especially on scarce open green space like Moore Park nor impact on adjacent residents. The funds should be invested in desperately needed community sport facilities across NSW.

I strongly object to the Government's 'Stage 1' application, being assessed by Planning NSW, i.e. demolishing the stadium and adjacent Sheridan, Roosters, Waratahs and Cricket NSW buildings. I object to the proposed building of a new stadium with 45,000 seats and space for 55,000 people at concerts. There are serious flaws in the government providing a proposed building envelope and general functions without buildings designs or operational details. These at the very least need to be supplied.

Other reasons for my objection are:

- \* Premature demolition: A rushed demolition will force any future Government to continue the project after the March 2019 election. The demolition must be refused at this stage without a detailed design and clear information on the impacts of a new stadium.
- \* Undisclosed expansion: While seat numbers barely change, the plan is for a mega-entertainment venue, with more and larger events, and more intrusion onto Driver Avenue and Moore Park. The real expansion plans and operational impacts must be made public in full as part of this application.
- \* Worse congestion: The application reports up to 60 per cent of patrons arriving by car--that's over 13,000 vehicles. Traffic modeling was carried out for cars arriving, but congestion is worse after games as

most people leave at the same time. The traffic study is inadequate and seriously underestimates impacts. It must be completely redone.

\* Cars on Moore Park: The application claims no new car parking spaces on site because it expects increased demand to be met by the Centennial Park and Moore Park Trust. Every car parking space generates extra traffic. The Trust must end parking on our parkland and abandon plans to expand car parks at the golf course, ES Marks Athletic Field and the Entertainment Quarter. Driving cars to visit the stadium will also increase greenhouse gas emissions. Cars to be permanently banned from parking on Moore Park, an important area of green open space for our community and visitors.

\* Public transport is inadequate: The only effective solution for event congestion is more and better public transport. The new light rail will only move at most 14,000 passengers per hour, leaving many people driving. The State government needs a metropolitan-wide strategy to deliver people quickly and easily to the stadium by public transport, walking and riding.

\* Destruction of trees: We have already lost too many trees at Moore Park, but at least 28 more trees are to be cut down, with 15 of them identified as 'worthy of retention with moderate to high landscape significant'. These trees must be protected.

\* Construction impacts: This unnecessary demolition will create noise, air pollution and congestion from trucks, and with the new rebuild materials, will create more greenhouse gases. Concrete will be crushed on site with 'visual inspections' of dust and air quality.

I object to any plan to use the Moore Parklands for spectator parking - all parking should be taken off the grass and be restricted to the new facility, under built-on areas. Providing more parking just proves the light rail isn't expected to meet travel demand.

Please do not rush through the demolition when there is a benefit-cost ratio of less than one - I prefer to

see my stamp duty invested in something meaningful, like a new high school in the Eastern Suburbs, the metro to Randwick, more footpaths and pedestrian priority to, through and around Moore Park -- projects with a BCA of more than 1!

I object to the use of my stamp duty and poles / wires revenue to chop down more trees. I do not support any more tree loss -- just a few of the 8 trees for each significant tree lost for the light rail were replanted and most of the puniest ones were planted around the grasslands used for overflow car parking for events. If these are chopped down it is a double whammy for our community continuing to lose tree cover.

I also object to any further degradation of the walk, run or bicycle ride between Centennial Park and the CBD -- every new project puts more barriers to walking, running or riding when it should actually make it easier for people to be active and improve their health.

1. This proposal is inconsistent with the NSW Government's Directions for a Greater Sydney: 'Eastern Harbour City - The established Eastern harbour city will continue to grow as Australia's global gateway, with a strong financial, professional services, FinTech, health and education economy.'

There is no mention of a focus on redeveloping a sporting complex.

2. This proposal is also at odds with NSW Government's Premier's Priorities which contain no reference to sport or redeveloping a sporting complex.

3. By attempting to redevelop a coastal Sydney location, this proposal is at odds with NSW Government's efforts to showcase Parramatta as the geographical centre of Sydney.

4. This proposal highlights the NSW Government's inability to develop an appropriate facility the first time round.

5. This proposal demonstrates the misalignment in priorities between the current state government and the people who elected them.

6. In summary, this proposal is a gross misuse of public funds. Its backers need to consider what else could be done with the money and how this 'legacy' affects their reputations in the years ahead.

Firstly, I support the redevelopment of the SFS and believe the knock down rebuild offers an opportunity to rectify some of the problematic aspects currently encountered by spectators trying to access the venues.

The clear majority of stadia in the world have access from all sides which allow efficient spectator circulation and provides a superior customer experience. The current experience of both the SFS and the SCG is that they're 'trapped', both towards Fox Studios/The Entertainment Quarter and each other. By way of SCG example, accessing the non-member section of the Bradman/Noble stands from Driver Avenue (ticket sales) requires a three-quarter loop inside the various stands, up and down stairs and escalators. Similarly, accessing Gate H of the SFS from the Venue Services Office requires a three-quarter loop around the SFS.

A knockdown rebuild offers a unique chance to rethink spectator circulation and improve access which would benefit both the SFS and the SCG experience. While 'SFS Event Circulation' on figure 36 of the Environmental Impact Assessment does allow for full circulation, the access is missing from the 'SCG Events and Double Header Circulation'.

I believe the site access and event management design should be amended to reflect this issue/opportunity.

#### LOCATION

The construction of a large new stadium on this site is unwise being in such close proximity to the SCG.

Public transport to the ground is difficult. A new stadium of this size should be built on a heavy rail line like the MCG or Allianz Stadium Munich.

#### BULK

The 'potential stadium form' as illustrated in the 'Design Guidelines' is double the height of the existing Sydney Football Stadium.

Though the capacity is said to be the same as the existing stadium (45,000) the extra bulk must be due largely to the high number of corporate boxes planned.

#### CAPACITY

The capacity of 45,000 seats is not necessary due to the numbers normally attending NRL or ARU games. A stadium of 25,000 would suffice.

Grand Finals, Interstate, International games can be played at Homebush.

## FUNDING

There is no indication in the SFS exhibited documents of the breakdown of general admission seating and corporate seating or whether corporations will pay a premium at the outset to secure corporate boxes.

The taxpayer should not foot the bill for corporate boxes.

## DEMOLITION OR REUSE OF EXISTING BUILDING

It is apparent the manager of the existing stadium has not carried out proper maintenance, allowing the fabric to deteriorate, which is unfortunate.

Should the existing buildings be demolished prior to the March Election and there is a change in government it may be preferable to return the site to passive community use.

The Sydney Football Stadium was designed in 1985 by the notable architectural firm, Philip Cox Richardson Taylor and Partners Pty Ltd. It is one of a suite of outstanding Cox buildings built in Sydney and is part of the enduring image of the celebratory function of the Bicentennial. In 1988 the firm produced five major steel structures in close collaboration with internationally renowned engineers Ove Arup and Partners. Three were sited at Darling Harbour, Sydney's major Bicentennial project.

The Sydney Football Stadium is acknowledged as an aesthetically distinctive design and was a significant technical innovation; after 1988 the Cox practice's 'white stadia expressionism' was adopted globally by other architects and influenced the design of international sports and exhibition facilities.

It has been recognised as an important contributor to world and Australian architecture in numerous publications and the award of the 1988 Building and Civil Design Award, Institute of Engineers and as a Finalist World Quaternario Award.

The Sydney Cricket Ground and the Sydney Football Stadium are in the vicinity of a range of heritage items, notably the Fox Studios (former Sydney Showground) and Centennial Park. The Sydney Football Stadium is one of a suite of related structures in the SCG representing two of the nation's favourite pastimes football and cricket and sport generally.

The Sydney Football Stadium has strong associations with some of the country's most prominent sports people and holds undoubted social value in the wider community. It is technically expressive, rejoicing in

the bravado of both sporting and structural exploits.

**Content:**

The residents of South Paddington do not agree that this development should proceed. The Trust took delivery of a new stadium in the late 1980s and large amounts of money have derived from its use particularly TV rights to the filming and transmitting of the games. The stadium is rarely full and frequently has less than 10,000 patrons. The cost benefit study showed a ratio of below one, therefore not cost effective.

This development was not even revealed to the cabinet ( who were asked to support it without having been briefed)

The public had no access until a member of government crossed the floor making it was impossible for the government to withhold the details.

We now know assumptions made in that cost benefit analysis depended on an increase in the number of concerts and an increase in major events which are not currently approved. These were the fantasies underpinning the failed cost benefit analysis.

The community of South Paddington does not support this development because we believe it to be unnecessary and the funds should be spent on hospitals schools and public transport

We do not believe that the Trust should be given the funds for the redevelopment using 3/4 of a billion dollars needed elsewhere in NSW.

The stadium is barely 30 years old and should be repaired. The cost of the repair should be paid for by those who make money from using the stadium mostly television contracts to stream games. Attendance at games is dropping.

The redevelopment should be voted on at the NSW election. However the rush to begin is exactly because the Premier and Alan Jones know how deeply unpopular this proposal is. The development has had substantial opposition in the community and rushing it through knowing this smacks of corruption. Trust members have told our community that the plan is to tear the stadium down before the election so the rebuild cannot be stopped.

The disruption to the South Paddington community will be major with noise dust trucks traffic snarls etc. The voters of NSW and the South Paddington community have indicated major opposition.

The South Paddington community have a very poor relationship with the Trust over years. The Trust has tried before to argue for more concerts and major events but have been restricted to 6 per year due to the impact on nearby high density terrace housing and apartments in Moore Park and Centennial Park. The impact already of fireworks going off late at night disturbing children, elderly people and pets has been raised many times. The Rugby 7s in 2017 led to the riot squad being called to Paddington after a large group of intoxicated fans fought in the street and trashed the local parks.

The Police have consistently supported the Paddington community and the liquor licensing police are more than familiar with the adverse social impacts.

The repairs should be done and the remainder of the public's money should be spent on refitting the local hospitals and schools.

Its very sad that in view of major opposition to this development the Premier and Alan Jones think they can bully the electors and defy common sense and knock down a building that is just 30 years old.

As a long-term member of the Sydney Cricket and Sports Ground Trust, a local resident and a New South Wales tax payer, I would like to register my strong objection to the proposed demolition and redevelopment of the Sydney Football Stadium.

I have a number of concerns regarding the proposal as follows:

- Sydney Cricket and Sports Ground Trust, has had responsibility for the operation and maintenance of the award winning Sydney Football Stadium (SFS) for some 30 years. If, as claimed, the state of the facility is so poor, then the Trust has been derelict in its responsibility for maintenance to ensure that the facility continues to conform with appropriate safety, access and security standards. The Trust now seeks taxpayer subsidy to meet its obligations in this regard. An appropriate comparison may be the Sydney Opera House, which is older than the SFS and has been managed and maintained in order to meet contemporary safety, access and security standards, without the need for demolition and rebuilding.
- The proposed additional encroachment of the Trust footprint onto Moore Park as a consequence of the redevelopment. Moore Park has already been severely affected by the construction of the Tibby Cotter footbridge, the light rail development, and its use as a car park for the Trust venues. Given the rapid development in the surrounding area, every effort should be made to maintain green space which is accessible to the entire community.
- There has been limited, if any, community consultation on the proposed development. This would appear to contradict the Government's own policy on development and expenditure initiatives. This Inquiry is a welcome opportunity to redress that shortcoming.
- The apparent disregard of the Government for its own criteria for major projects in relation to the cost - benefit ratio.
- Given the magnitude and scope of this proposal, there does not appear to have been an appropriate planning and approval process - the announcement and development of the proposal has occurred within an extraordinarily short time frame, and it appears that plans to commence demolition are proceeding while this inquiry is in progress.
- As a longstanding member of the SCG, I am also concerned with the manner in which the Trust has conducted itself. There has been no consultation with members, and very limited information as to how members' interests will be considered and how access to facilities will be maintained while any proposed development is undertaken. However there was a very sketchy overview of the new proposed stadium without asking the views of members.
- I am particularly concerned about the potential conflict of interest of Trustees who have personal, and commercial, relationships with the lessees of the Entertainment Quarter, which has been identified by the Trust as a potential site for location of Member services such as the gym during the proposed redevelopment. There is no clarity regarding the extent to which NSW taxpayers may be subsidising these interests. I would hope that this issue has been considered by the Government as part of the criteria for funding the development, should it proceed.
- In view of the magnitude of the infrastructure development needs in NSW - specifically public transport in greater Sydney, and in the Health and Education systems across the state, I believe there are higher priorities for the quantum of funds proposed for this wasteful project. If any funds are to be allocated to the Sydney Football Stadium, they should be limited renovation to meet safety and disability access standards.
