#### Description of the development consent

Development of the Meadowbank Education and Employment Precinct Schools Project, comprising:

- construction of an up to seven storey multi-purpose school building
  - site landscaping, open space and open and covered sports courts/fields, tree removal and planting, fencing and pathways
  - flooding and stormwater management works
  - 60 staff car parking spaces
  - school building identification signage.

#### Description of modified proposal

The modification application seeks approval for changes to the public domain works including pedestrian infrastructure upgrades and related conditions including:

- deletion of the requirement to provide a 2.5m wide shared user path along the western side of Hermitage Road.
- changes to footpath upgrade requirements along Bowden Street and Squire Street.
- changes to pedestrian crossings at/near the following intersections:
  - See Street and Macpherson Street
  - Rhodes Street and Macpherson Street
  - Mellor Street and Victoria Road.
- deletion of the requirement to provide upgrades to streetlights.
- provide flexibility in the timing for completion of public domain works where existing overhead/inground services or approval cause delays to the required works.
- amend timing for the submission External Works Compliance Certificate and Works-as-Executed Plans to Council.

The modification application also seeks consent for extension of the approved construction hours to allow construction of the public domain works, where approval has been granted under Section 138 of *Roads Act 1993*.
