Subject: Request to waive requirement to prepare a Biodiversity Development Assessment Report

I refer to your correspondence received on 27 November 2018 seeking to waive the requirement to submit a Biodiversity Development Assessment Report (BDAR) with the State significant development application for the University of Newcastle – Honeysuckle Campus Stage 1A (SSD 9510).

Under section 7.9(2) of the Biodiversity Conservation Act 2016 (BC Act);

"Any such application is to be accompanied by a biodiversity assessment report unless the Planning Agency Head and the Environment Agency Head determine that the proposed development is not likely to have any significant impact on the biodiversity values".

The authority of the "Planning Agency Head" to determine whether a proposed development is "not likely to have any significant impact on biodiversity values" was delegated to Directors within the Planning Services Division on 21 December 2017.

I have reviewed your request having regard to Sections 1.5 and 7.3 of the BC Act and Clause 1.4 of the Biodiversity Conservation Regulation 2017, and have determined that the proposed development (SSD 9510), as described in your waiver request, is not likely to have any significant impacts on biodiversity values.

The delegated Environment Agency Head in the Office of Environment and Heritage has also determined that the proposed development is not likely to have any significant impacts on biodiversity values in a letter dated 10 January 2019 and a copy of that letter is attached.

Therefore, a waiver under section 7.9(2) of the BC Act is granted for the proposed development and a BDAR is not required to accompany the SSD application.

If there are any amendments to the proposed development, this BDAR waiver determination will not be valid. You will need to either prepare a BDAR or lodge a new request to have the BDAR requirement waived.

Request to waive requirement for BDAR – University of Newcastle, Honeysuckle City Campus Development – Stage 1A - 16 Honeysuckle Drive, Newcastle (SSD 9510)

I refer to the request from University of Newcastle (prepared by Ethos Urban and dated 27 November 2018) to waive the requirement for a Biodiversity Development Assessment Report (BDAR) to be submitted with the State significant development (SSD 9510) application for Stage 1A of the University of Newcastle's Honeysuckle City Campus Development. The Office of Environment and Heritage (OEH) notes that it issued a previous BDAR waiver (DOC 18/232423-1 and dated 27/4/2018.) for the first stage of a Concept Plan (SSD 9262), which covered a much larger area (but included the current site).

I have reviewed the information provided by the applicant and determined that the proposed development as described in Ethos Urban correspondence is not likely to have any significant impact on biodiversity values. Therefore, the application does not need to be accompanied by a BDAR. The determination is attached for you to provide to the applicant.

SCHEDULE 1 - Description of the proposed development




Figure 1 Aerial Image of the Site

State Significant Development (SSD 9510) under the *Environmental Planning and Assessment Act* 1979 for the Stage 1A development of the University of Newcastle, Honeysuckle City Campus Project, located at 16 Honeysuckle Drive, Newcastle. The proposed development is within the Newcastle City local government area. The Stage 1A Site is legally described as Part Lot 1 in DP 1163346 (as schematically shown on Figure 1).

The SSD application for Stage 1A will seek approval for the development of a new building on the Honeysuckle City Campus that accommodates the University's School of Creative Industries (SOCI) and an 'Innovation Hub'. These facilities will provide learning studios and flexible spaces for coworking, meetings and informal collaboration. In summary, the Stage 1A proposal includes:

- Design and construction of a single standing, multi-storey building on the corner of Worth Place and Honeysuckle Drive;
- Space for the use of the Innovation Hub, SOCI and building fit out to make these spaces suitable for their uses; and
- Associated landscaping and infrastructure works.

A preliminary built form layout plan is provided in Figure 2, delineating the location of Stage 1A in context of the wider Concept Plan for the long term development of the campus.
