RE: Section 4.55(1) modification to correct minor administrative errors and misdescription in relation to SSD 9536 – expansion of Wyong Hospital

On 29 August 2019, the Minister's delegate approved the above project for the expansion of Wyong Hospital. It has come to our attention that there were a number of minor administrative errors and misdescriptions in relation to document references at condition A10, C34, C35 and C36. HI request the following minor corrections as follows:

Regarding condition E16, we clearly outlined in our Response to Submissions Table (Attachment A to our RtS dated 07/06/19) that the new access road would be restricted to emergency and service vehicle use only.

HI are of the view that the consent that was granted remains substantially the same development and that the proposed modifications are to correct minor administrative errors and misdescription. There is no impact of this change on the outcomes of the consent.
