The Wyalong Solar Farm is a utility scale renewable energy project with an output measuring up to 130 megawatts (MW) that will generate clean and renewable electricity from the power of the sun. The project will generate enough electricity to power the equivalent of approximately 50,000 homes.

The \$130 million dollar project is located approximately 7 kms northeast of West Wyalong NSW within Bland Shire Council. The site was chosen due to its proximity to the grid network, lack of environmental constraints and flat land. The project will involve the installation of solar panel arrays across an area of up to 260 hectares within the project area and a local connection to the 132 kV Essential Energy Transmission network, expected to be within the site boundaries.

The solar farm will comprise of up to 350,000 solar photovoltaic modules, known more commonly as 'solar panels'. The solar panels are identical in type but larger in size to those used in residential solar installations installed on homes throughout Australia.

The solar panels will be installed on ground-mounted frames that will slowly track the daily horizontal movement of the sun. The solar panels will generate direct current ('DC') electricity that will be inverted to alternating current ('AC') via power conversion units. The power conversion units located within the site will feed AC electricity into an onsite power reticulation system before the power is centrally collected and dispatched to the local electricity distribution network via the Essential Energy transmission network.

To Whom it May Concern,

We refer to the NSW Department of Planning & Environment Resource & Geoscience Division response to the NSW Department of Planning & Environment Planning Services request for advice on the Secretary's Environmental Assessment Requirements (SEARs) for the Wyalong Solar Farm, dated 7 September 2018.

In their response, the Resource & Geoscience Division recommend that ESCO Pacific should undertake a search of current mining and exploration titles and applications near the proposed Wyalong Solar Farm.

The Wyalong Solar Farm project is a utility scale renewable energy development with a capacity of up to 130 MW that would generate clean and renewable electricity from the power of the sun. Wyalong has been chosen as the location of the solar farm because of the relatively high solar irradiance in the region and the capacity of the Essential Energy electricity network to transmit the power generated by the project. The development site is located within an existing highly modified and cleared environment, therefore there is no dense bushland and only limited vegetation in or surrounding the site. The site comprises a mixture of grazed and cropped paddocks.

The solar farm operation will comprise up to 350,000 solar photovoltaic (PV) modules, known more commonly as 'PV Modules' or 'solar panels'. Access to the site during construction and operation is expected to be from the Newell Highway. More information about the project is available via the following link.

The project is coincidental with Exploration Licence EL8430 held by Argent Minerals identifying two copper-gold targets - Theia and Narragudgil (see Figures 1 & 2). The figures show there are currently no direct overlapping interests in the site. There are no operating quarries in the immediate vicinity of the site.



Furthermore, we can confirm there are no proposed offsite biodiversity offsets or supplementatry biodiversity measures that would reduce access to prospective land for mineral exploration.

We have received preliminary advice from our lawyers, and intend to provide a formal response to you after further considering the advice.






