						insurances. Our family has group Insurance that covers Public Liability but because we do not carry out an enterprise in this field, we cannot get the Workers Compensation Insurance as it's not available to individuals.			
						This needs to be sorted out confidentially as soon as possible, as it should not be a reason to exclude our family, particularly when we descend from the Traditional Aboriginal people of this area and ought to be engaged in the management of our places within our Country. Other registered parties like the Land Council or other organisations have this sort of insurances due to the need for their organisations to have it, as they pay wages. On the other hand, as Traditional Custodians and independent registered parties, we all work in different fields and this sort of insurance is provided by their employers. We have always been involved in the management and protection of our heritage and this has only been an issue once in NSW recently. I will call as soon as I can, once the number to call is clarified. 1. Introduction

1.1 Project Initiation and Scope

In June 2018, Niche Environment and Heritage Pty Ltd (Niche) was commissioned by TSA Management Pty Ltd (TSA) on behalf of NSW Health Infrastructure to undertake an Aboriginal cultural heritage desktop review at Lot 102 DP870722, 771 Cudgen Road, Cudgen, NSW for the proposed development of the new Tweed Valley Hospital (TVH) at this location (hereafter referred to as the Subject Area, see Figure 2). A draft Master Plan has been prepared by Bates Smart which addresses the health services required to meet the needs of the growing population of the Tweed Byron region and incorporates proposed culturally appropriate spaces for the resident and local community.

The purpose of the initial review was to identify Aboriginal heritage requirements, or constraints to inform the preparation of an Environmental Impact Statement for the declared State Significant Development under the NSW State Environmental Planning Policy (State and Regional Development) 2011. The review identified the potential for Aboriginal cultural heritage constraints within parts of the Subject Area and recommended a full Aboriginal Cultural Heritage Assessment (ACHA) with Aboriginal community consultation be completed.

This document presents the proposed methodology for ACHA process and proposed survey of the Subject Area. It will form part of the ACHAR.

This proposed methodology has been designed to conform to the relevant requirements of various advisory documents and guidelines. These guidelines and documents include:

- Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in New South Wales (OEH, 2011a)
- Aboriginal Cultural Heritage Consultation Requirements for Proponents 2010 (Part 6 National Parks and Wildlife Act, 1974) (DECCW, 2010a)
- Code of Practice for Archaeological Investigation of Aboriginal Objects in New South Wales (DECCW, 2010b)
- The Burra Charter: The Australia ICOMOS Charter for Places of Cultural Significance (Australia International Council on Monuments and Sites [ICOMOS], 1999)

1.2 Objectives of Aboriginal community consultation

The objective of community consultation is for Aboriginal people to have the opportunity to improve assessment outcomes by:

- Providing relevant information about the cultural significance and values of the Aboriginal object(s) and/or place(s).
- Influencing the design of the method that will be used to assess the cultural and scientific significance of Aboriginal object(s) and/or place(s).
- Actively contributing to the development of cultural heritage management options and recommendations for any Aboriginal object(s) and/or place(s) within the Project Area; and
- Completing a review and providing comments on the draft assessment report before it is submitted to government.

The following report is designed to inform the Registered Aboriginal Parties (RAPs) for the Project on the proposed archaeological investigation and provide them with the opportunity to comment on the methodology.

2. Project information

2.1 The Project

Niche was commissioned by TSA on behalf of NSW HI, to prepare an ACHAR report for the proposed new Tweed Valley Hospital.

2.2 Where is the proposed lot of land

The project area is known as the Tweed Valley Hospital. The facility will be located on Lot 102 DP870722 at 771 Cudgen Road, Cudgen immediately west of Kingscliff, north coast of NSW.


2.3 What is being proposed?

The project consists of:

- Delivery of a new Level 5 major referral hospital to provide the health services required to meet the needs of the growing population of the Tweed-Byron region, in conjunction with the other hospitals and community health centres across the region
- Master planning for additional health, education, training and research facilities to support these health services, which will be developed with service partners over time. These areas will be used initially for construction site/ compound and at-grade car parking.
- Delivery of the supporting infrastructure required for the new hospital, including greenspace and other amenity spaces, campus roads and car parking, external road upgrades and connections, utilities connections, and other site infrastructure.

3. Existing cultural heritage knowledge

3.1 Preamble

Understanding the past and present environmental contexts of a Subject Area is requisite in any Aboriginal archaeological and cultural heritage investigation (DECCW, 2010a). This provides an understanding of what activities would have taken place there in the past and the likelihood any trace would remain below the surface.

The following section provides details of the environmental characteristics of the Subject Area. The section concludes by considering how the environmental character of the Subject Area affects the way in which the area would have been occupied by Aboriginal people in the past, and how Aboriginal archaeological sites will be distributed across the landscape.

3.2 Topography, landform and waterways

The Subject Area is located within the North Coast Bioregion, which ranges from coastal sand dunes to steep slopes and gorges of the Great Escarpment. The dominant topographic characteristic within the Cudgen locality is a defined east west running ridge that links the Cudgen Plateau to the Kingscliff coast. The Subject Area incorporates part of this ridgeline, affording views towards topographic features within the broader region. Together with the elevated ridgeline, the Subject area also includes the associated north facing slope and a section of adjacent low-lying wetland, formed as part of a larger interdunal swale that runs parallel to the Wommin Bay coastal foreshore. Other water sources include Cudgen Creek and its associated estuary situated approximately 700m south east of the Subject Area.

3.3 Geology and soils

The ridgeline and slopes of the Subject Area is characterised by tertiary volcanic soils associated with the Mt Warning complex including red and brown friable loams (NSW OEH: Subregions of the North Coast Bioregion) as well as iron oxide sandstone, and haematite which is known as a source of red ochre for Aboriginal people in the area. Rock types include basalt of the Lamington Volcanic Series with minor occurrences of rhyolite and tuff. The lower lying sections of the Subject Area are identified as Quaternary beach and sand dune deposits associated with the coastal interdunal unit and prone to waterlogging.

3.4 Vegetation


Vegetation mapping identified that the Subject Area incorporates a narrow section of Melaleuca and Swamp She-oak forest associated with the wetland and interdunal landform. The Subject Area also incorporates a section of subtropical rainforest, consisting of a high canopy with a medium to dense forest understory immediately west of Turnock Street. It should be noted that the majority of the Subject Area has been cleared of vegetation, including the ridgeline and slopes and some of the low-lying ground adjacent to the wetland.

3.5 Recent land use activities

The majority of the Subject Area has experienced extensive disturbance from land clearing activities from sugar cane cultivation in the 1870's to present day agricultural use. Much of the rock across the Subject Area has been raked up and piled along the boundaries and across the property, forming minor manmade earthworks. As a result, much of the Subject Area is described as moderately to highly disturbed, and therefore any artefact bearing soil deposits have been heavily disturbed.

3.6 Summary

The extent of disturbance from previous and current farming activities, within much of the Subject Area, mean it is unlikely that there will be undisturbed archaeological deposits related to Aboriginal occupation. This includes the elevated ridgeline and north facing slopes within the Subject Area. The lower-lying areas adjacent to the wetland may be less disturbed and there exists some potential for subsurface archaeological deposits in these areas. Additionally, landscape features such as those commonly identified as places of importance to Aboriginal people are noted within and adjacent to the Subject Area. There is the potential for intangible cultural heritage values to exist.





4. Archaeological Context

4.1 Preamble

It is a requirement under the 'Code of Practice for Archaeological Investigation of Aboriginal Objects in New South Wales' (DECCW 2010a) (hereafter referred to as the 'Code of Practice') that archaeological assessments synthesise available information from previous archaeological and ethno-historical studies to provide a context and baseline for what is known about Aboriginal cultural heritage in the Subject Area. In accordance with the Code of Practice, this section reviews heritage registers to identify known Aboriginal heritage items (Section 4.2), identifies and describes previous archaeological investigations in the Subject Area , the local and wider region (Section 4.3), reviews ethnographic and historical studies (Section 4) and then synthesises and discusses this information with reference to the landscape context (Section 3.2). This synthesis will provide a summary of the main issues and regional character of Aboriginal land-use and its material traces and its likely nature and distribution of within the Subject Area.

4.2 Heritage Registers

4.2.1 National Heritage Registers

Under the EPBC Act Amendments (No. 88, 2003), two mechanisms have been created for the protection of heritage places of National or Commonwealth significance: the National Heritage List (NHL) and the Commonwealth Heritage List (CHL)

(http://www.environment.gov.au/heritage/places/national/index.html).

The NHL provides protection to places of cultural significance to the nation of Australia, while the CHL comprises natural, Aboriginal and historic heritage places owned and controlled by the Commonwealth. The Australian Heritage Database (AHD) is maintained by the Department of Sustainability, Environment, Water and Population and Communities (DOSEWPC) and contains information about more than 20,000 natural, historic and Indigenous places including places listed on the world, national and commonwealth heritage list and those under consideration.

• A search of the Australian Heritage Database was undertaken on 26 July 2018. There are no heritage listings relevant to the Subject Area.

4.2.2 NSW State Heritage Register

The State Heritage Register (SHR) lists items that have been assessed as being of State heritage significance to New South Wales. Items appearing on the SHR are granted protection under s.60 of the *Heritage Act* 1977.

 A search of the SHR was completed on 26 July 2018. There are no Aboriginal heritage sites listed on the SHR within the Subject Area.

4.2.3 State Heritage and Conservation (s.170) Registers

Section 170 of the Heritage Act requires that State Government Agencies establish and maintain a Heritage Conservation Register for heritage items located on land under their control or ownership. Items listed on a s.170 Register are listed on the State Heritage Inventory (SHI) and bound by the regulations of the Heritage Act.

4.2.4 The Tweed Local Environmental Plan (LEP) 2014

Each Local Government Area (LGA) is required to create and maintain an LEP that identifies and conserves Aboriginal and historical heritage items. These items are protected under the EP&A Act.

 A search of the Tweed Local Council LEP (2014) was undertaken on 26 July 2018. No Aboriginal heritage sites were listed in the LEP.

To promote awareness and added protection for Aboriginal Cultural Heritage within the Tweed LGA, the Tweed Shire Council commissioned and have subsequently adopted the Aboriginal Cultural Heritage Management Plan (ACHMP) in July 2018. A key component of the ACHMP was the development of a Landform Mapping and Predictive Modelling (LMPM) tool which highlights places with known and predicted Aboriginal cultural heritage. The predictive modelling framework is based on a range of criteria including but not necessarily limited to, previous archaeological assessment and the landscape context for the area (ACHMP 2018).

A search of the LMPM was conducted on 26 July 2018, identifying that most of the Subject Area has been mapped as part of a larger area containing 'Predicted Aboriginal cultural heritage' (refer to Figure 4). For those areas nominated within this category, the ACHMP (2018: 96) recommends:

"...an appropriate level of assessment be undertaken and consultation completed with the Aboriginal community at the commencement of a site specific planning proposal or masterplan and prior to the lodgement of a planning proposal."

4.2.5 National Parks and Wildlife Act Registers (AHIMS)

A search of the AHIMS was conducted on 19th June 2018 (AHIMS Client ID 351986), revealing that no previously recorded sites have been identified within or in proximity to the current boundaries of 771 Cudgen Road.

4.3 Review of Previous Archaeological Assessment within a local context

Niche has previously undertaken an Aboriginal cultural heritage desktop review of the Subject Area.

Findings from the desktop review and site visit

A search of the AHIMS was conducted on 19th June 2018 (AHIMS Client ID 351986), revealing that no previously recorded sites have been identified within or in proximity to the current boundaries of 771 Cudgen Road. Consequently, proposed activity at 771 Cudgen Road would not impact on any registered Aboriginal sites. However 771 Cudgen Road is situated in a landscape setting comprising of an elevated terrace and slope, situated above a swamp and heavily vegetated drainage system. These landscape features are listed in the Due Diligence Code as signifying a strong likelihood that Aboriginal objects may be present:

- within 200m of waters, and
- located on a ridge top, ridge line or headland.

771 Cudgen Road represents a likely landscape for sites of past occupation with the potential for camp sites, a prominent position over the swamp and proximity to a wide variety of resource types.

A brief site visit was undertaken on the 15th June 2018 to better understand local conditions and the possible constraints associated with 771 Cudgen Road. The photos below show the environment, level of previous disturbance and remnant vegetation within the Subject Area. The visual inspection noted varied levels of surface and ground disturbance across the Subject Area with the elevated sections of the landscape including the terrace and associated slope subject to extensive disturbance from vegetation clearing and agricultural activities such as ploughing, planting of trees and other farming related activities.

The extent of disturbance along the southern, eastern and western boundaries indicates low potential for intact soil profiles and low potential for Aboriginal objects in these areas. The low-lying areas adjacent to the wetland and remnant vegetation appeared to be less disturbed and there may be potential for intact subsurface archaeological deposits within these areas.

The presence of remnant vegetation suggests greater potential for an intact land surface and therefore higher potential for Aboriginal objects including within archaeological deposits in this area. Visual inspection noted no visible signs of high level disturbance, with this area appearing largely intact.

Landscape features such as those features commonly identified as places of importance to Aboriginal people were noted within and adjacent to the Subject Area, including the swamp and remnant vegetation. Some residual intangible cultural heritage may still exist within 771 Cudgen Road that may not result in a physical trace or indicator of their existence in the landscape.

A search of the AHIMS register also identified several archaeological investigations relevant to the Subject Area.

Assessment author and year	Description of assessment
Everick (2012)	Extensive work by Everick Pty Ltd (among others) at Kings Forest, approximately 3km southwest from the current Subject Area is important in examining the local area in a broader Aboriginal cultural heritage context. A total of 17 Aboriginal sites comprising of midden, artefact scatter complexes and isolated finds were recorded within the Kings Forest area. These sites were situated across a number of landscape features including highly modified interdunal swales, low slopes associated with a small ridge and wetland surrounding Cudgen Lake and Cudgen Creek. Given the large area under examination, the archaeological finding when combined with the Aboriginal cultural heritage values were viewed as part of the broader Aboriginal cultural landscape for the Tweed. Given the relative proximity of this assessment and some shared landscape characteristics to the current Subject Area.
Everick (2010)	Cultural Heritage Assessment of Lot 490 Kingscliff Resort, Kingscliff an unpublished report: This assessment was completed prior to the development of ecotourism facilities at this location. It reviewed archaeological findings in a local context, noting the presence of artefact scatters in and around the Cudgen and Kingscliff coastal streams and adjacent low lands and made predictive statements regarding site types for the area. The study found that earlier sand mining in the area had caused extensive disturbance to any potential insitu archaeological deposits in the interdunal system and as a result no Aboriginal sites, or areas of archaeological potential were identified. Ground surface visibility across the area was noted as generally poor.
Davies (2004)	Aboriginal Cultural Heritage Assessment: 355 Cudgen Road, Cudgen an unpublished report: The purpose of this assessment was to undertake a review and field survey to identify if any Aboriginal cultural heritage values existed within the proposed development zone. This assessment included a comprehensive review of the archaeological material of the area at the time, as well as the Aboriginal history of the region. Given the close proximity of this assessment to the current Subject Area, this report has been used in developing site prevalence predictions for the current assessment.
Piper (2001)	Archaeological Assessment: Lots 26C / 26D DPP10715 and Part Lot 4 CP 727425 Cudgen, an unpublished report:

This assessment reported on the results of an archaeological assessment of Lots immediately to the north of the Subject Area, within the area identified as wetland and interdunal coastal zone. No Aboriginal sites or areas of archaeological potential were identified during the assessment and the landforms within the area were concluded as not being of a type that would be archaeologically sensitive. Given the close proximity to the current Subject Area, Piper's report was used in developing site prevalence predictions for the current assessment.

Piper (2000)

Archaeological Assessment at Lot 2, Crescent Street, Cudgen an unpublished report:

This assessment examined an area of low lying alluvial floodplain, northwest of the current Subject Area, identifying a campsite with a low density artefact scatter composed of flakes, scrapers, cores and retouched flakes. The site was noted as highly disturbed but considered significant given that the site represents the only occurrence of a camp sites with artefacts to be identified on the Tweed River flood plain (Piper 2009-29-30).

5. Proposed methodology for the project

5.1 Aboriginal Cultural Heritage Assessment (ACHA)

The Aboriginal Cultural Heritage Assessment (ACHA) will follow the guidelines set out in the:

- 'Aboriginal cultural heritage consultation requirements for proponents 2010 (OEH 2010)
- 'Code of Practice for Archaeological Investigation of Aboriginal Objects in New South Wales' (OEH 2010b)
- 'Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in New South Wales' (OEH, 2011a).

The ACHA will aim to:

- Identify the cultural and archaeological values that may be present within the Subject Area to help inform any future works proposal.
- Synthesise the results of technical investigations, the significance of the finds made, make
 management recommendations on requirements for additional approvals including Aboriginal
 Heritage Impact Permits (AHIPs).
- Incorporate the process and results of consultation, undertaken in compliance with the Aboriginal cultural heritage consultation requirements for proponents 2010 guidelines.

The ACHA will follow the general methodology described by the tasks below:

Full site inspection:

- The site inspection will focus on areas within the Subject Area that would be disturbed by surface
 infrastructure include buildings, internal roadways, and carparks, as well as areas designated for
 hydrological and landscaping/gardening works.
- The inspection will also concentrate on those areas which retain higher archaeological potential within the Subject Area.

Reporting:

• A draft report will be prepared to satisfy the requirements of the Office of Environment and Heritage Archaeological Code of Practice, the Consultation Requirements for Proponents and the Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in NSW.

5.2 Aboriginal community input points for the assessment

The guidelines suggest several points of input for RAPs, including:

- during development of the methodology (i.e. now)
- during meetings / site inspections / fieldwork
- during review of the draft cultural heritage report

In addition to this we welcome any input and suggestions regarding the heritage assessment at any stage of the consultation process. We anticipate having the ACHAR finalised by early September, which requires the report to be reviewed by the Aboriginal stakeholders by early October 2018. Niche cannot guarantee being able to incorporate any information after this date.

5.3 Methods of assessing heritage significance

Heritage significance will be assessed by considering each cultural, or archaeological site, against the significance criteria set out in the *Guide to investigating*, assessing and reporting on Aboriginal cultural heritage in NSW (OEH 2011).

In all cases the assessment of significance will be informed by the Aboriginal community, and this will be documented in the ACHAR. If any culturally sensitive values were identified they would not be specifically included in the report, or made publicly available, but would be documented and lodged with the knowledge holder providing the information.

5.4 Critical timelines

Critical timelines for the ACHA of the Project are outlined below.

Please note that these timelines are estimates at this stage and are provided to allow forward planning of personnel and resources.

- Provision of comments on Proposed Methodology: no later than 5pm, 6 September 2018.
- Collation of cultural significance information: ongoing throughout process until end of draft ACHAR review period.
- **Site Inspection: 7 September 2018** (Immediately after methodology review period ends, dates to be confirmed with RAP availability).
- Provision of a draft ACHAR (including proposed management and mitigation measures) to RAPs for review: 12 September 2018
- Provision of comments on draft ACHAR: 9 October 2018
- Finalisation of the ACHAR in consideration of comments received: 11 October 2018
