





I have lived in Kingscliff for having regularly visited here for 25 years and worked in the local medical community periodically for 15 years. My wife has lived here for and her family I feel I am well credentialed

to understand the impact of a hospital development of this size on the local environment and community.

There is no doubt that the Tweed area needs better health infrastructure and I am grateful for the efforts of each of the tiers of government in securing the necessary funding for this project, which frankly is long overdue. I would very much like to see a new regional hospital in this area but this end does not justify the means used to rezone State Significant Farmland (SSF) at Cudgen when there are valid alternative sites.

My objections to the EIS for using 771 Cudgen Road as a hospital are as follows:

- Rezoning of State Significant Farmland (SSF) is wrong. The land on the Cudgen plateau is unique for its highly fertile red soil and close proximity to urban centres. It must be preserved. Rezoning would lead to a significant detrimental

effect on the local farming community by fragmenting it, which would impede on its long term viability. As a young Kingscliff family we value greatly the availability of fresh, locally grown produce and purchase this weekly from local farm stores and the farmer's market. Our property on Kingscliff hill is very fortunate to have a vein of Cudgen red soil running through it. The contrast in fertility from adjacent sandy soil on other properties is stark and it is inconceivable that we could be concreting over hectares of this, thus depriving future generations of its immense benefits. This area is truly unique with vistas of the adjacent hinterland and it is unacceptable that rezoning could occur. There is no point having legislation for SSF if it can be immediately overturned by the whim of a political party at any time.

- Subsequent rezonings of surrounding land (some of which is conveniently owned by National Party members/donors) will see the decimation of the local farm community. I know or have spoken to local farmers and they are gravely concerned for their future. The uncertainty is creating unneeded stress/anxiety in this valued community.
- I have witnessed similar developments in my clinical roles over the years, most recently at Gold Coast University Hospital. The hospital precinct there has lead to huge changes in the

Southport/Parkwood community as ancillary services and transport links are developed around a large tertiary/quaternary hospital. It is disingenuous to suggest that hospital footprint on Cudgen plateau will not extend beyond the parcel of land suggested for rezoning. In fact, in my 15 years as a specialist doctor working throughout NSW, Queensland, Canada and the U.K., I have never seen a hospital this size exist without adjacent services requiring at least 2-3 times the footprint of the hospital clinical site. It is fanciful and misleading from Geoff Provest and Health Infrastructure NSW for them to suggest that adjacent farmland on the eastern side of Tweed Coast Road will not be unduly affected. Similarly, the pocket of rainforest at the north eastern aspect of the site opposite the local library will be destroyed. To think this could happen to somewhere as beautiful as Kingscliff and Cudgen is simply unacceptable and wrong. Particularly when there is non-arable land within a few kilometres which could adequately fit the purpose of the hospital, or the existing site with infrastructure links could be redeveloped. - A hospital on this site in Cudgen which is so closely located to the local village risks having a profound detrimental effect on the thriving and local tourism and food industry, which is just starting to flourish. We are just now seeing acclaimed chefs and restaurateurs relocating from Sydney, Melbourne and Brisbane to this region due to availability of fresh farm grown produce in an idyllic coastal setting. Why would we put a unique growing industry at risk?

- The building of a hospital of indeterminate height in the SEPP proposal (but which is likely to be 9 stories high) contradicts the Tweed LEP, local community plans and the Tweed Shire council regulations for a 3 storey height limit in Kingscliff. The removal of height restrictions could then lead to subsequent over-development of Cudgen and Kingscliff as opportunistic developers seize on this precedent. Please do not allow Gold Coast style overdevelopment to occur in northern NSW. My family chose to live in the Tweed area for the village lifestyle, which has been preserved by long standing commitments of council and successive state and federal members to protect this area. The Kingscliff local community plan reflects this as an ongoing vision of council and locals, developed after much consultation. People have moved to this community from all over Australia to raise their family in a village environment which has always been supported by local council infrastructure. So it is wrong for a different tier of government to impede on longstanding community expectations when other options are available.
- The existing roads and transport infrastructure are already inadequate to service the current population, let alone meet the demands of construction of a \$534 million hospital with 850 employees and subsequent patient population. Cudgen Road, McPhail Ave, Pearl Street and Kingscliff Street are the main thoroughfares around the hospital site from either direction. They already have potholes and 4.5t weight limits, and at times of bad weather are already unsafe. The fairly recent addition of Salt Village/Seaside to Kingscliff did not bring the planned new road/bridge across Cudgen creek to Tweed Coast Road which was promised. So traffic for residents on Kingscliff is already bad due to ill-conceived developments but will be much worse on the poorly maintained local roads with heavy truck traffic. Add to this ambulances, helicopter flight noise and the ambience of this community will be changed forever.

In summary, rezoning SSF on Cudgen plateau to allow construction of a new hospital is wrong and would lead to irreparable damage to the environment in the town of Kingscliff, its vibrant village community and does not serve the best interests of the wider Tweed community when other alternative sites are available. The best interests of NSW are not served if the Environment Department does not recognise the flaws in the EIS and allows the precedent of overturning hard fought recognition of SSF for Cudgen plateau to be rezoned at the convenience of a political party and Health Infrastructure NSW.





- 1. Permanent loss of State Significant Farmland a food bowl with soil that can grow just about anything. If this hospital is built on 16 hectares of irreplaceable, highest quality soil, it won't stop at 16 hectares because a hospital of this size will need more ancillary buildings, services, car parking, facilities etc etc. The demand for nearby land will be to the point that the farmers will be pushed off and the SSF protection will be lost. It is common knowledge that parcels of farmland near the proposed hospital site have already been acquired by individual owners who are ready and waiting for this development opportunity. 500ha is required to hold the State Significant status. It only needs further loss of approximately 30ha to lose this protection.
- 2. I've been told at public meetings that a hospital has a working life of approximately 60 years, after that there is ingrained contamination as well as the building being too old to continue maintaining and, is out of date. If this is the case then what would this new hospital be turned into at the end of its life, after it has claimed the farming land and turned Kingscliff into a health precinct city rather than the family holiday and tourist destination it has been planned to be? Will the State Government, in 60yrs time just brush it aside and look for another 'greenfield site'? I can only imagine what wonderful advances in medicine, technology and building design will be available by then. Why permanently sacrifice irreplaceable, food producing land protected by State Significant zoning? We can have both if the hospital is in a more suitable location. In my opinion, Tweed Heads. If not the existing site, what about the Border Racetrack for example. There are many sites available for genuine consideration.
- 3. During the public meeting earlier this year at the Tweed Heads Civic Centre the Minister Mr Brad Hazzard was asked to answer why his department abandoned the redevelopment and expansion of the existing Tweed Heads Hospital? His response was with such casual abandon it left most of the audience in shock. "I changed my mind". When asked why he changed his mind he said, "because I can". The extraordinary amount of resources, time, money and effort that goes into formulating and passing legislation is shown, by Mr Hazzard, to be useless and worthless. Surely that is not the case.
- 4. The matter of flight paths is reason why some sites offered were subsequently rejected. Not the Kingscliff site, although it is directly under flight paths both arriving and departing. The departures are because of operational requirements due to the ongoing, rapidly increasing number of aircraft. Can you tell me how a nine-storey

building with a helipad on the rooftop directly under a flight path, is going to be workable and safe? What does CASA think of this?

- 5. Floods. The proposed site of the new hospital is above flood level but, certainly not the roads leading to it. For a hospital that is stated 'to service the entire Tweed region', not many people will be able to access it in flood times.

 My huge concern is if the Tweed Coast Road is built up to such an extent that it is above flood, then what will happen to Kingscliff homes? Unless you live on the hill, you'll have no chance. Caught between the built-up Tweed Coast Road, Kingscliff hill, the ocean and the Tweed River nowhere to go. Is that just more bad luck for some?

 During Cyclone Debbie in March 2017 Kingscliff, including the proposed site, was totally cut off for 3 days. The existing Tweed Hospital was not evacuated or flooded.
- 6. I would like to know why the existing hospital has been allowed to become so supposedly inadequate. The increase in population didn't happen overnight. Why haven't continual upgrades been occurring as required over the years? Is this our local members dropping the ball? I see room for expansion at the existing hospital site, with the resuming of part of Powell Street, some Civic Centre, some Bowls Club and Church and the university block. The long-term Strategic Plan, up until March 2017 had the Health Precinct existing in Tweed. That Plan for expansion of the existing site is drawn up, why has it been cast aside? I was aware a new hospital, buildings, upgrades and more services were needed and being attended to but not at any point did I know Kingscliff was already the selected site. Within a week or two it seemed it went from being at Tweed Heads, our regional health and education precinct, to Kingscliff. Nobody can tell me why. The community has not been consulted anywhere near adequately. Now being told 'lives are at risk' because the hospital isn't being built quick enough. If that is truly the case, then the poor governance that is behind this, is shameful.
- I will give you another dimension of Kingscliff and Cudgen. Many residents are family members and descendants across generations of Tweed dairy farmers and banana farmers who have owned holiday shacks/houses at Kingscliff and Cudgen for many decades and come for their holidays away from the farm. Many residents are also long-time owners of fishing holiday shacks as is my case with my father. At retirement age it is time to move into those comfortable beach holiday homes. Of course, residential development will happen as population increases. Our local Tweed Shire Council is very transparent. Plenty of community consultation has and still is occurring regarding our Local Strategic Development Plan. Not so with this proposed hospital. It is a complete surprise and unknown. It wasn't even factored in, or discussed, for our 30yr Local Strategic Plan. Kingscliff in recent years has been heavily marketed as a family friendly holiday tourist surfing destination. That marketing is definitely working. It is getting busier and busier. The restaurants are loving it. Spending school holidays at Kingscliff is extremely popular and it's guaranteed that a lot of these holiday makers are also spending time and money at farmers markets, roadside stalls, open gate farms and more. Farmers are a huge part of our Kingscliff community and this creates a wonderful beach/farm vibrancy. Development on the proposed site will put all of the growth in our holiday sector, our largest employer, at risk.

8. If the State Government will not expand or rebuild at Tweed Heads, I would like the Clothiers Creek interchange site to be seriously considered. H2 on your Government website. It presents a wonderful opportunity to build a completely self-sufficient hospital. Right on top of the M1. It doesn't matter that the infrastructure is lacking. Implement it. That ample parcel of land is, as far as I can see, sloping dairy farmland. Perfect for a self-sustainable sewerage system within the development. Same for water catchment and storage. Build its own accommodation hub, pharmacy, food hall and grocery store. With advances in structural engineering, a sloping block is overcome. That land is out of flood and right on top of the M1, with connection roads north south east and west. Public transport will follow.

State Government bureaucrats don't live here and have no apparent concern for what their policies mean for the people who do live here. No doubt, some Government decisions are good. However, time and again they are not making good decisions about developments being in line with local character, the existing human and natural environment and future plans for an area. I could give examples but now is not the appropriate time. In my opinion Federal and State departments must listen to communities, through the Community Consultation process, when decisions need to be made. The current Community Consultation process regarding this hospital is a farce. I was selected to be on a community consultation committee with 11 others and our Councillors and Council staff. Mr Provest had allowed us 6 weeks to find a new site. The restrictions made it impossible. I felt insulted. So much time and tax-payers money has been wasted by Mr Hazzard, Mr Provest and other Government Departments writing patronizing responses to thousands of letters which express genuine, verifiable concerns from residents, who are being told in these response letters that 'the hospital is needed', with nothing being provided in response to the concerns and why the site should be relocated. Many people I talk to who are well known to me or I associate with regularly, don't believe Kingscliff is the best location for the new hospital but when I ask them if they've written to the Premier or Government Departments and Ministers, they say, "what's the point, they're a law unto themselves, in fact, if a law gets in their way, they simply change it!" I believe, for every letter you are receiving, there are two more that people are not even bothering to write.

Our own hugely popular Mayor Katie Milne and the majority of our Councillors believe the hospital should be at Tweed Heads. Our Mayor Milne is a tireless, hands on, community spirited leader. I'm approaching retirement age and have lived on the Tweed since my midtwenties. I have never seen a Mayor work as hard as her for the best interests of the current environment and community and maybe even more importantly, the future environment and community. She is incorruptible and a responsible decision maker.

In closing I trust the hospital will be relocated and the farmland preserved as State Significant Agricultural Land for future generations. Ensuring as much viable food producing land in our Tweed region as possible, in an uncertain future.

It is reasonable to believe, that status, is the Government's assurance the land will remain protected farmland.

I express my objections and concerns in point form and hope they will each be acknowledged and responded to:

- 1. Permanent loss of State Significant Farmland a food bowl with soil that can grow just about anything. If this hospital is built on 16 hectares of irreplaceable, highest quality soil, it won't stop at 16 hectares because a hospital of this size will need more ancillary buildings, services, car parking, facilities etc etc. The demand for nearby land will be to the point that the farmers will be pushed off and the SSF protection will be lost. It is common knowledge that parcels of farmland near the proposed hospital site have already been acquired by individual owners who are ready and waiting for this development opportunity. 500ha is required to hold the State Significant status. It only needs further loss of approximately 30ha to lose this protection.
- 2. I've been told at public meetings that a hospital has a working life of approximately 60 years, after that there is ingrained contamination as well as the building being too old to continue maintaining and, is out of date. If this is the case then what would this new hospital be turned into at the end of its life, after it has claimed the farming land and turned Kingscliff into a health precinct city rather than the family holiday and tourist destination it has been planned to be? Will the State Government, in 60yrs time just brush it aside and look for another 'greenfield site'? I can only imagine what wonderful advances in medicine, technology and building design will be available by then. Why permanently sacrifice irreplaceable, food producing land protected by State Significant zoning? We can have both if the hospital is in a more suitable location. In my opinion, Tweed Heads. 

It has been chosen by Ministerial desree, without adequate consideration of other sites and without democratic consultation wit hthe community, or consideration of major social and community concerns.

It targets State Significant Farmland when other site options exist. These lands were designated to be protected, not destroyed by the Government.

It revises the 2017 North Coast Regional Plan by Ministerial decree, shifting the Tweed Hospital away from the major population hub of the City of Tweed Heads to the Town of Kingscliff with no prior community consultation whatsoever. That is outrageous.

What concerns me most is the total ignoring, lack of consideration of, and plain ignorance regarding the impact on the town of Kingscliff - with its local family holiday beach and fresh food tourism industry. It will distort the core business focus and culture of the town from tourism and small crop agriculture to health services without any discussion with the community.

The 9 story hospital does not fit the landscape or townscape of the area chosen. Whatismore, it undermines the community's hard fought 3 story limit in Kingscliff (and the coastal villages) by changing its character by building at least one multi-storey building that will over-whelmingly dominate the skyline. No aesthetic concerns, no community concerns, no judgement or balance was exercised in this choice of location.

Relocating the hospital away from the economic hub of Tweed Heads removes a key economic driver (hospital) and betrays Tweed Heads business owners and the residents with medical issues who invested their life savings in homes with hospital proximity.







We both strongly object to the site chosen by HI for a major regional referral hospital in Kingscliff. Of over 50 sites offered, it is hard to believe that Kingscliff was chosen, as on so many levels it is a huge mistake

It seems to me that Kingscliff was chosen because it is above flood level. What a pity that all the access roads Into Kingscliff flood, so it will be completely inaccessible like it was for two days last year.

While talking about access roads, did the experts who chose this site realise that they all converge onto Cudgen Road, which is already the busiest road in Kingscliff? There is no way that it will cope with the huge volumes of traffic generated by a major hospital, even if it is widened to four lanes. The local council hasn't had any funding to repair the local roads since the 2017 floods, so how they are expected to come up with 200,000 million dollars, in conjunction with NSW Roads, to build major arterial roads which will be needed.

The local council strongly object to the site choice as well, and have asked for a parliamentary inquiry into the whole process of site selection. My dictionary tells me that the opposite of transparent is opaque, and that is what has happened here. At no stage was there community consultation before the site was announced, and it was only after community voiced their outrage was a farcical process undertaken. We have since found out that HI were negotiating with the owners from December 2017, and there was no way they were going to consider other sites, even though the locals were given a token 6 week limit to come up with a better alternative.

There are better alternatives, either the greenfield site at Kings Forest or building on land in Tweed Heads near the current hospital. This makes sense as all the necessary infrastructure as well as public transport is there already. Also the majority of the population lives north of the Tweed River, and the projected figures state this will still be the case in 2036.

Kingscliff will become a parking lot if the hospital is built there. There are 652 car parks planned for the hospital site, whereas it needs at least double this number which still won't be enough. The local streets will be parked out and family and friends of locals will be unable to park outside their homes. Anecdotal evidence from every major hospital site shows cars parked at up to a kilometre radius from the buildings. This will surely happen in Kingscliff, which will destroy the lifestyles of every resident there, plus every Cudgen Resident.

The current hospital is the economic driver for Tweed Heads. If it is relocated Tweed Heads, which is meant to be the regional city, will become a ghost town as there will be no customers for the businesses there.

The local council is against this site, joining over 8000 locals who have signed a petition against the site. There are also 4500 members of the Relocate group who oppose the choice of site. The tourism industry is worth hundreds of millions to our town, but it will be annhilated if high rise buildings of up to nine storeys are built in Kingscliff. It will become a medical city, not a gorgeous seaside village! Our point of difference from the Gold Coast is that we don't allow high rise developments. Once the precedent is set by a high rise hospital, all other inappropriate developments will follow, and there goes Paradise!

I would like to register my strong support for the proposed amendments under the State Environmental Policy - Tweed Valley Hospital SSD18_9575.

I have not made any political donations, reportable or otherwise, in the last two years. I do not wish for my details to be identified following close of the public exhibition period.

Reasons for support

I live in the Tweed Shire and currently operate a small commercial farming operation in a region near Kingscliff/Cudgen (Duranbah). I am a professional agricultural scientist with 40 years experience of agricultural productivity and sustainability matters in Australia and abroad. My reasons for supporting the proposed amendments are outlined below and have been informed by both this local experience and extensive professional background.

Proposed Amendments - Rezoning of the Land

- I support this rezoning. While I am also a strong supporter of the protection afforded to "State Significant" agricultural land, I consider the need for a quality hospital cited above the maximum probable flood level to be a far higher priority.
- I recognise that suitable sites that meet all the necessary criteria are very limited and from my perspective there has been a very comprehensive and technically sound process undertaken that has led to the identification of the preferred site at Kingscliff/Cudgen.
- I understand the areas of quality agricultural land to be impacted are minimal (minimum of four and maximum of eleven ha depending on quality measures) and I do not consider there to be any significant negative impacts on other farming operations in the Cudgen region.
- In fact, if local farming operations were to embrace the opportunities afforded by the hospital development the net impacts could be very positive for the region. These opportunities include new higher value local marketing opportunities and regional branding that links land, food and health benefits.
- There are also significant opportunities to develop knowledge and research-based partnerships on land food and health synergies involving the TAFE, Universities and other research agencies, the new Hospital and allied health developments and the local farming community.

• I support this proposed amendment to the building height code. While I profess no expertise in design of hospitals I can understand that operational efficiency and health outcomes require a certain proximity amongst services and facilities. I think good architectural design and landscaping can ensure a building of 6 to 9 stories can still fit well into this landscape. In fact, this scale of building is still lower than the nearby iconic Norfolk Pines of the Cudgen village.

<u>Proposed Amendments – Minimum Lot Size</u>

• I support the removal of minimum lot size controls to facilitate the development of the proposed health service facilities.

<u>Proposed Amendments – Floor Space Ratio</u>

• Clearly the Floor Space ratio Controls for that part of 771 Cudgen road, Cudgen are not appropriate for the proposed hospital. Hence I support the proposed amendment to remove these controls.

It is important to note that my support for the proposed amendments to land zoning, height of buildings, minimum lot size and floor space ratio relates ONLY to the development of the Tweed Valley Hospital at the proposed site of 771 Cudgen Road, Cudgen. I consider the opportunity to have a new hospital developed for this region to be so significant with such a broad range of community benefits that it warrants these amendments in this specific case.

I would like to register my **strong support** for the concept proposal and EIS on Stage 1 Works for the Tweed Valley Hospital SSD18 9575.

I have not made any political donations, reportable or otherwise, in the last two years. I do not wish for my details to be identified following close of the public exhibition period.

Reasons for support

I live in the Tweed Shire and currently operate a small commercial farming operation in a region near Kingscliff/Cudgen . I am a professional agricultural scientist with 40 years experience of agricultural productivity and sustainability matters in Australia and abroad. My reasons for supporting the proposed amendments are outlined below and have been informed by both this local experience and extensive professional background.

- 1. The Tweed Valley region is in urgent need of upgraded hospital facilities. On this point there seems to be no dispute within the community or amongst the health professionals that service the region.
- 2. Based on my close reading and engagement, the site selection process to date has been professional, evidence based and transparent and this has been in the face of determined efforts by some to create political points of difference that confuse and divide the community.
- 3. To double the size of a hospital on top of the existing over-stretched facility that is on a space-constrained site only one quarter the size of what is needed is clearly not feasible. The extra costs and time delays would be extraordinary and a poor quality hospital outcome almost certain.
- 4. The future growth demographics and equity of accessibility to hospital services for the Tweed to Bryon region mean a greenfield site south of the Tweed River is a sensible and equitable approach.
- 5. The landscapes of this region mean that flood-free land is in short supply and the chosen site best meets the published selection criteria on size, accessibility and flood free status.
- 6. It is unfortunate that agricultural land will be lost as part of this development but in my mind the community needs for a quality hospital site are higher order needs that continuation of the current relatively low value agricultural activity. I have more detailed comments on the agricultural impact assessment below (i.e. Appendix F of the EIS).
- 7. The Kings Forest site comes with very high risks of cost over-runs and time delays. This region is basically a cow paddock surrounded by environmentally sensitive landscapes. The costs of land filling to get the site above PMF levels is only one source of additional cost. There are huge risks of extra costs for essential infrastructure and huge risks of delays in terms of environmental approvals and management strategies.

- 8. The Cudgen Rd site offers excellent prospects for a state of the art hospital design that is in harmony with the local environment and which offers connections to open "parkland" and natural ecosystems that add to the overall "healing" qualities of the hospital.
- 9. Careful design of the hospital environs holds promise to deliver a significant "community dividend". Basically a hospital in this Cudgen Rd location offers the opportunity to upgrade community accessibility across the Kingscliff to Cudgen axis. Currently public infrastructure including several schools, a TAFE college, a library and public pool are very poorly serviced by safe and attractive walking / bike paths.
- 10. The positioning of the hospital adjacent to the TAFE College is a great opportunity for the region to develop training and employment opportunities for the region's young people. At present there are very few "knowledge intensive" employment opportunities in the region the hospital/TAFE combination creates a great opportunity if the community has the foresight to fully embrace it.

<u>Specific comments on the Agricultural Impact Assessment (Appendix F of the EIS)</u>

I found Appendix F to be an evidence-based analysis of the consequences of losing State Significant agricultural land. Key points include;

- Of the 16ha of land in question, I understand from this report only 4 ha is of high quality in terms of slope, soil depth and freedom from sub-soil rock outcrops. The total value of agricultural output on a "whole of time" discounted basis was estimated at around \$1M. This value to the region is infinitesimally small when compared to the economic and social benefits flowing from the proposed hospital. The Agricultural Impact Assessment found no spillover impacts on other agricultural activities on the Cudgen Plateau. I would agree with that as there are no longer any agri-supply chain businesses in the region with Murwillumbah being the primary source of agriinputs and market distribution for Cudgen/Duranbah farmers.
- My local observations over the last 16 years tell me these soils are at high risk of erosion once any significant slopes are involved. In fact, the sustainability of continuous cultivation and deep soil disturbance as currently practised in sweet potato production is highly questionable. An analysis of the Cudgen rainfall record over the last 100 years shows that the region can get extreme rainfall events (>200 mm per day) in any month of the year. Cudgen Creek runs to the ocean red with the soils of the Cudgen and Duranbah plateaus in such circumstances. So the current farming system is ultimately unsustainable in terms of the erosion risks. In time, new farming systems that maintain perennial vegetative cover need to be developed. Some local farmers maintain the current practices are economically viable and I don't dispute that in individual circumstances but it is hard to see how small areas of land that is costing in the order of \$200 to \$400K per ha can compete in the long term with larger areas in places like Bundaberg Qld (where most of the sweet potato industry has moved after starting up in Cudgen) for perhaps 25% of those prices. Often we say in agriculture that one has to "get big or get out". Getting "big" on small patches of very expensive land in Cudgen is not really an option. So in these circumstances the future lies in "staying small but getting different".
- The fact that at least 25% of the current State significant farm land in Cudgen is not used for agriculture provides some evidence for the limited economic attractiveness of traditional agricultural production in the region. There have been a number of properties shift into what is effectively agricultural tourism of late and that may be a growing trend as landowners look for diversifying income sources.
- Developing policy settings that encourage full utilisation of the State significant soils for sustainable agricultural production might be a far better way of maintaining a viable agricultural sector in Cudgen than blocking the hospital! There is a role for local and State Govt's to work together on that policy.
- The bottom line is that farming in the Cudgen/Duranbah region does need to evolve to adapt to environmental threats, economic pressures and market opportunities (i.e., stay small but get

different). This is the big challenge facing the region's farmers – not the hospital! In fact, the hospital could in time become a new opportunity itself for farmers to reposition their food businesses to better align with food-health and lifestyle trends. That won't be easy but looking backwards (or worse still putting heads in the sand/soil) certainly won't help.

- 1. The proposed Tweed Valley Hospital (TVH) site compromises the community of Kingscliff and the agriculture & tourism, the economic basis of the Tweed shire.
- 2. This proposed development contradicts the Tweed LEP and the draft Kingscliff Locality Plan which, after 3 years of extensive community consultation, wants to maintain building height limits of 3 storeys. This is a direct threat to the social, visual and economic viability of Kingscliff and the adjoining Cudgen plateau farmland.
- 3. By selecting State Significant Farmland for a proposed large hospital site the State Government is destroying valuable, drought free, arable and productive land instead of protecting it. This contradicts that State Significant Farmland cannot be developed if there are other viable sites. Over 50 sites were identified and 3 were short listed. Therefore there are OTHER VIABLE SITES.
- 4. The NSW State Government has ignored the Tweed Shire Council resolution to oppose locating the TVH on prime agricultural land. The Council deemed that the social, economic and community impact was too great.
- 5. The relocation of the Tweed Heads Hospital to the proposed TVH site will gut the economy of Tweed Heads city. The large majority of Tweed Heads residents with medical issues invested their life savings to live within proximity to the hospital. Access to the proposed site by public transport is limited. This will adversely affect an ageing population in Tweed Heads.
- 6. The relocation of the Tweed Heads Hospital to the proposed TVH site will isolate the majority of Tweed Shire resident whole north of the Tweed River in time of flood. This happened in March/April 2017 when Kingscliff was isolated by flood waters which is contrary to the EIS claims that the proposed will improve flood access.
- 7. There was no community consultation prior to the announcement of the selection of the proposed site. This again is contrary to claims made in the EIS.
- 8. The proposed site has been touted as the "best" site "chosen by experts". This was a commercial decision based on the limited sites offered for sale at one particular point in time in 2017. Other land

not for sale was never considered even though the compulsory acquisition powers used to acquire the Cudgen site from a reluctant owner. These same powers could have been used to select and acquire any site in the Tweed Shire.

- 9. The lack of transparency with regard to the full cost of relocating the hospital, by passing on the future cost of extending transport and utility infrastructure to other public authorities such as the Tweed Shire Council supported by the rate payers.
- 10. Diminishing and compromising the quality of life of both Kingscliff and Cudgen residents with intense urbanisation, increased traffic congestion and demand for parking, 24 hour ambulance emergency sirens and 24 hour emergency aircraft arrivals, all night flood lighting of the entire site, loss of rural and village ambience and lifestyle. The impact will be devastating to our way of life.
- 11. 



There are more suitable sites available, such a building a tower block in Tweed Heads next to the current hospital, or else at Kings Forest, which is shovel ready to go.Reports in the press that Kings Forest floods are not true, the 33 hectares set aside for this mega development are above the PMFLevel.

I wish to quote from Council Minutes as they so eloquently capture my feelings on this frankly disturbing decision, made with no community consultation whatsoever by so called experts who don't know the area. If the locals had been asked, they would have explained the common knowledge that Cudgen Plateau is built on a bed of basalt rock, which would require major blasting by explosives to dig down deep enough for necessary foundations. This would be a very expensive exercise and also requires a separate EIS as the blasting is within one kilometre of residential areas. Your â€oeexperts― missed vital information here.

To quote. â€oethe fundamental project description is untrue. The stage 2 project description fails to disclose that this proposal is not merely for a new hospital, but for a relocation of an existing hospital as stated in the SEARS application. The stage 1 early and enabling works are intended to be substantial enough to commit the applicant to the removal of the current hospital from Tweed Heads to Kingscliff. Therefore any statement of environmental impact should address the social, transport and economic consequences of hospital removal from Tweed Heads in addition to its reestablishment at Kingscliff. As the application is currently posed, the significant impacts of relocation will never be publicly examined in the first or second EIS, or any other forum before the project is fully committed. The applicants must be formally required to examine the impacts of relocation Inclusion of stage 1 activities that are not early or enabling works, such as bulk earthworks, piling and associated works, I ground infrastructure, stormwater and drainage works, and retaining walls need substantial commencement. They require knowledge of the building and carpark levels and footprints, subterranean floor levels, foundation levels and stroke water nutrient loads, and volumes and discharge points. This knowledge will only be available when both detailed hospital design drawings and their associated environmental impacts are provided to the DoPI. None of these is currently proposed to be included in stage 1, as required by Act Div 4.4 S4 22 (5).

The detailed hospital design must be completed and the environmental consequences fully described if included in any stage 1 SEARS.

Non disclosure of adverse effects seeks to commence and lock in a major environmental impact activity contrary to numerous environmental planning instruments without substantial prior public disclosure of the interim social, economic and environmental effects of the project which are indisputably of major consequence. In this respect it fails to satisfy the clear intent of the EP&A Act 1979, as well as the moral duty of the NSW Government to engage in a transparent and consultative

process, an issue it emphasised when recasting the legislation in 2017.―

There are other sites available from the 50 which were considered, which meet all the criteria. Please go back to the drawing board and start this process afresh. The \$48 million recently given to keep the <u>current hospital</u> fully functional should be an adequate stop gap measure.
