RE: SSD-9670 Variation for Extended Working Hours (Condition C5)

This letter is to formally request a variation to the approved construction hours for the development at 2-6 Hassall St, Parramatta under conditions C4 and C5 of the SSD-9670 for construction works including tower crane 1 dismantle.

Requested amended working hours:

5.00am to 7.00am

Date/duration of the requested variation:

Saturday 15th May 2021

Reason for the requested variation:

Tower crane 1 dismantle works for this project have been scheduled to run over Saturday and Sunday the 15th and 16th of May. A mobile crane is required to dismantle the site tower crane, which is restricted to transport outside of peak hour travel, so the equipment will need to arrive on-site before 7am. RCC are proposing to coordinate arrival and setup of the mobile crane and associated equipment to commence on-site at 5am so dismantle works can begin at 7am and run the full approved construction hours.

A road occupancy license for Hassall St has also been approved by Transport NSW (attached to this letter as appendix) and all relevant authorities and stakeholders have provided approval for the road closure. The early setup of mobile crane and associated equipment will ensure that the dismantle works run the full 2 days of approved construction hours so works do not extend outside of the approved road closure times and will ensure roads are re-opened in time for public transport use before weekday peak commuter travel times as agreed with public transport authorities.

All affected stakeholders, including neighbouring properties, will be made aware of the extended hours (once approved) via the contact emails for local businesses or via letter drop in mailboxes to local residents.
