

## EXHIBITION OF STATE SIGNIFICANT INFRASTRUCTURE MODIFICATION REQUEST

### SYDNEY METRO WEST

#### Description of approved project concept

The Sydney Metro West project concept includes construction and operation of new passenger rail infrastructure between Westmead and the central business district of Sydney, including:

- Tunnels, stations (including surrounding areas) and associated rail facilities;
- Stabling and maintenance facilities (including associated underground and overground connections to tunnels); and
- Modification of existing rail infrastructure (including stations and surrounding areas).

#### Description of approved construction

The approved major civil construction work (Stage 1 construction between The Bays and Westmead) comprises:

- Enabling works, such as demolition, utility supply to construction sites, utility adjustments and modifications to the existing transport network;
- Tunnel excavation and tunnel support activities between Westmead and The Bays;
- Station excavation for new metro stations at Westmead, Parramatta, Sydney Olympic Park, North Strathfield, Burwood North, Five Dock and The Bays;
- Shaft excavation for services facilities;
- Civil work to support the construction of a future stabling and maintenance facility at Clyde; and
- Excavation of a tunnel dive structure and associated tunnels at Rosehill to support a connection between the future Clyde stabling and maintenance facility and the mainline metro tunnels.

A previously approved modification clarified the intent and timing for preparation, or Environmental Representative's endorsement, of various reports and other documentation.

The approved Stage 1 construction includes excavation of a tunnel dive structure and the realignment of Kay Street and Unwin Street at Rosehill.

#### Description of proposed modification

The proposed modification relates to the major civil construction work at the site of the future stabling and maintenance facility at Clyde and would include:

- Rosehill dive structure relocation and extension; and
- Kay Street and Unwin Street realignment.
