Subject: Condition A25 - amendment of Planning Agreement timeframe

Dear Jack,

This is a request to amend the date by which Cessnock City Council and Snowy Hydro are to enter a Planning Agreement, with regards to the Hunter Power Project (Kurri Kurri Gas-Fired Power Station) development, as required by condition A25 of Infrastructure Approval application number SSI-12590060.

Negotiations with Council have been positive and are progressing well, however, further time to that provided for in condition A25 is needed to complete the processes required by both parties to put in place a Planning Agreement. This includes elected Council endorsement and a public exhibition period. Please refer to the appended email from Karen Forsyth (Senior Infrastructure Contributions Planner, Cessnock Council) to Angela Felton (Hunter Project Community Liaison Manager).

A25 provides for an "other timeframe agreed by the Secretary". As such, it's requested that the timeframe for Cessnock Council and Snowy Hydro to enter into a Planning Agreement be amended to 'by December 2022'.
