Parramatta Light Rail Stage 1 State Significant Infrastructure approval - SSI 8285 Correction to Administrative Modification dated 21 December 2018

In October 2018, Transport for NSW lodged an administrative modification to modify various conditions within Critical State Significant Infrastructure approval for Parramatta Light Rail Stage 1. The purpose of the administrative modification was to clarify some inconsistencies in the terms and requirements of the conditions of approval.

The Department of Planning and Environment approved the administrative modification on 21 December 2018. The approval included a revised set of conditions (modification instrument) with a modification assessment report in support of the revised conditions of approval.

In reviewing the modification instrument and the modification assessment report, TfNSW has identified a number of inconsistencies between the two documents including minor typographical errors. Attachment 1 outlines the inconsistencies and minor typographical errors to the modification instrument.

In order to resolve these inconsistencies and errors, TfNSW requests the Department of Planning and Environment correct the modification instrument in line with the changes outlined in Attachment A.
