1 Purpose

The purpose of this document is to provide the results of the monthly monitoring of the Grey-headed Flying-fox (GHFF) camp located within Parramatta Park, Parramatta NSW, carried out as part of Parramatta Light Rail.

The reporting requirements are outlined in Section 6.3 of the Grey-headed Flying-fox Monitoring Program (PLR-TFNSW-CBD-PE-PRG-000001) prepared in accordance with Condition C9(c) of the Parramatta Light Rail (PLR) conditions of approval (Infrastructure Approval SSI-8285).

Every quarter, a suitably qualified and experienced fauna specialist (and supporting staff if required) are to monitor the GHFF camp and provide results within a monitoring report to be issued to the relevant TfNSW Project Manager(s). In addition, for the two months in between these monitoring events (i.e. the 'off-months'), trained TfNSW staff are to monitor the GHFF camp and provide a monitoring report for review by the suitably qualified and experienced fauna specialist.

In accordance with Condition E101, TfNSW are to submit these monthly monitoring reports to NSW Department of Planning, Industry and Environment – Environment, Energy and Science (DPIE EES) monthly and the Secretary quarterly.

The monthly monitoring reports include:

- Demographics and population data as per Appendix 4 of the GHFF Monitoring Program
- Map illustrating camp extent
- Sources and location(s) of potential disturbance
- Any supporting notes.

2 Methods

Monthly monitoring was undertaken by trained Transport for NSW team members on 24 June 2021 at Parramatta Park. Data was collected using the Proforma provided in the Grey-headed Flying-fox Monitoring Program (Appendix 4).

2.1 Data

2.1.1 Weather conditions

Ambient weather conditions including temperature, rainfall and wind were recorded (BOM 2021).

2.1.2 Flying-fox demographics

The number and species of flying-foxes present, approximate ratio of females to males, health condition, breeding activity or young present were recorded for each camp. A day time static count was used to estimate abundance at the camps.

2.1.3 Flying-fox behaviour

The following flying-fox behaviours were recorded if/when identified at camp:

- Resting
- Grooming
- Vocalising and interacting
- Mating or breeding activity
- Lifting in response to sudden noise
- Signs of stress
- Morbidity/mortality.

2.1.4 Camp extent

The camp's area of occupancy (spatial extent of the camp) was recorded.

2.1.5 Management and public use

The community's use of Parramatta Park for events and detectable impacts from nearby works were recorded to inform a complete understanding of the surrounding context.

3 Results

3.1 Weather conditions

On the day of monitoring, the area recorded 0.4 mm rainfall at the closest meteorological Station (Parramatta North (MASON'S DRIVE) 33.7917°S 151.0181°E 55m AMSL. The weather conditions are summarised in Table 3-1. Monitoring was conducted between 08:00 AM and 9:30 AM.

3.2 Flying-fox demographics

Parramatta camp contained 8,160 GHFF with approximate demographic population of 50:50:0 (males:females:juveniles) and with 0% dependent young flying with their parent over the GHFF camp. There were zero black flying-foxes identified in the camp (Table 3-2).

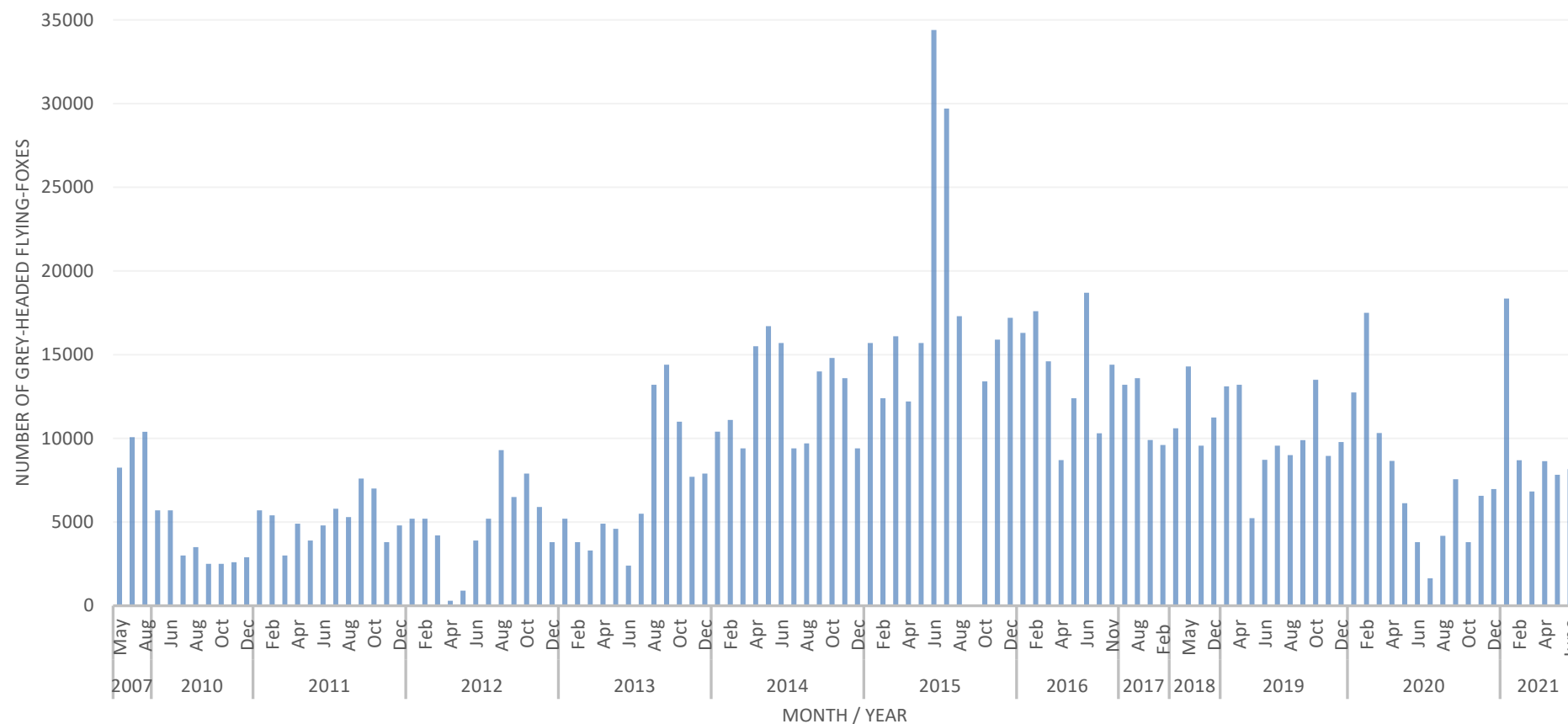


Figure 3-1 GHFF counts against baseline data (Source: Royal Botanical Gardens Martin J 2018 & Smith A 2018; NFFMP; TfNSW and Ecosure 2019, 2020, 2021)

3.3 Flying-fox behaviour and camp extent

The flying-foxes were demonstrating normal daytime behaviours, they were mainly resting due to cold weather and some were observed flying within the camp extents, GHFF demonstrated low signs of stress. The behaviour observed including vocalisation and resting (Table 3-3). At around 09:00AM low frequency intermittent banging noise could be heard - possibly due to truck and dog breaking at nearby PLR work site.

The area occupied by the flying-foxes at Parramatta camp is shown in Figure 3-2.
