### **Biodiversity**

1. BCD is satisfied that the amendment report addresses our previous concern

BCD's review of the Response of Submissions (RTS) report recommended that vegetation zones 1 and 3 within PCT 1590 are mapped as Lower Hunter Spotted Gum – Ironbark Forest endangered ecological community (EEC) consistent with mapping of vegetation zone 2 and the BAM calculator is re-run to determine the updated credit yield for these two zones and that the BDAR is amended.

The proponent has adequately justified that vegetation zones 1 and 3 do not represent the EEC (as per above) and have supported this with advice from Dr. Stephen Bell, a recognised specialist on this community (Appendix 9 of the BDAR). The BDAR has been updated and revised (August 2020) with this advice as previously requested.

BCD is satisfied with the response and no further assessment on this matter is required.

### Recommendation 1

BCD is satisfied that the amendment report has satisfactory addressed our previous comments on the RTS (dated 15 May - DOC20/334078-9) and no further assessment is required.
