Dear Mandana,

I refer to the submission of the request for agency input for the response to submissions, dated 30<sup>th</sup> April 2020, for the above development to Fire & Rescue NSW (FRNSW).

FRNSW reaffirm comments and recommendations previously submitted (2<sup>nd</sup> January 2020) in preparation of the Environmental Impact Statement (EIS) and maintain that they remain relevant in addressing fire and life safety considerations for the proposed development.

FRNSW notes that on page 63 of the EIS Submissions Report dated April 2020, "AGL notes that an updated FSS is required and acknowledges that this will be finalised upon completion of the detailed design" and "the proposals PHA will also be progressed to a Final Hazard Analysis at the completed design stage".

FRNSW are satisfied with this proposal and response to submissions.
