I refer to the Department's below email of 19 February 2021 regarding the Response to Submissions (RtS) for the exhibition of the Environmental Impact Statement (EIS) for State Significant Development SSD-10472 Expansion of the Museums Discovery Centre at 2 Green Road, Castle Hill (LOT 102 DP 1130271). Submissions need to be made to the Department by 4 March 2021.

Please refer to Endeavour Energy's submission made to the Department on 4 November 2020 regarding the exhibition of the Environmental Impact Statement (EIS) for State Significant Development SSD-10472 Expansion of the Museums Discovery Centre.

Endeavour Energy has reviewed Appendix B – Detailed Response to Submissions and Request for Information. The response provided is not particularly detailed ie. it does not address the matters from Endeavour Energy's submission on 19 June 2020 regarding the Request for Secretary's Environmental Assessment Requirements. However there is nothing in the response which is of particular concern to Endeavour Energy. From other RtS Endeavour Energy has usually been provided with a more detailed response matrix including a summary of all the matters in Endeavour Energy's submission addressing the more pertinent in detail and noting and agreeing to each of the other matters.

Endeavour Energy has noted that the application for connection of load process is 'underway and will be completed before any new connection works are completed'. The applicant and their Accredited Service Provider (ASP) should continue to work through the process with Endeavour Energy's Network Connections Branch who are responsible for managing the conditions of supply and can be contacted via Head Office enquiries on business days from 9am - 4:30pm on telephone: 133 718 or (02) 9853 6666).

Generally the Level 3 ASP is responsible for ensuring that the padmount substation location and design complies with Endeavour Energy's standards the suitability of access, safety clearances, fire ratings, flooding etc. As a condition of the Development Application consent the Department should request the submission of documentary evidence from Endeavour Energy confirming that satisfactory arrangements have been made for the connection of electricity and the design requirements for the substation, prior to the release of the Construction Certificate / commencement of works.

The other additional / revised documents provided with the RtS for the exhibition of the EIS do not appear to relate specifically to electricity infrastructure. Accordingly the recommendations and comments previously provided by Endeavour Energy in relation to the EIS essentially remain valid.
