## Ironstone Developments 'DEEP CREEK QUARRY'

I Geoff MacDonald of the above address, would like to lodge a formal objection to the above project.

The environmental Impact submission (EIS) is a fanciful document based on half-truths, misinformation and blatant lies. This document has been fictionally created to mislead the State Planning department and the project should be thrown out and the cost to the Government time and the local taxpayers should be sent to the applicant.

The project has not followed due diligence and it is an insult to the many hundreds of people that will be affected dramatically every day and does not even mention the tens of thousands that will be affected when they travel to the area on the weekends and especially school holidays.

There are incorrect references in the following key areas

#### Safety

The Bucketts Way Road would need to be a DUAL LANE ROAD with every bridge between the site and Pacific Highway at 12 Mile Creek widened. Additionally at the Bucketts way/ Pacific Hwy Intersection the Pacific Highway North Bound road should be built as a flyover bridge so that the cars turning right onto the pacific Highway and proceeding south should not have to cross the highway but rather pass underneath the North Bound traffic.
