Dear Sir or Madam

I refer to the Department's email of 8 March 2022 regarding the Environmental Impact Statement (EIS) for State Significant Development SSD-9409987 for Moss Vale Plastics Recycling Facility comprising 'Construction and operation of a plastics recycling facility with the capacity to accept and process up to 120,000 tonnes of plastic waste per annum. The facility would also manufacture plastic fibres and resins' located at 74-76 Beaconsfield Road, Moss Vale (Lot 11 DP 1084421) in the Wingecarribee Shire Local Government Area (LGA). Submissions need to be made to the Department by 22 March 2022.

As indicated in Appendix G - Engagement Outcomes Report, Endeavour Energy provided initial advice to GHD via an email on 11 November 2021 and subsequently a Technical Review Request was made to Endeavour Energy.

The EIS Main Document includes the following advice.

7.4 Utilities and services

Figure 7.5 provides an overview of the existing services within proximity to the proposal site.

7.4.1 Electricity

An electrical connection would be required to supply electricity to the plastics recycling and reprocessing facility as described in Table 1.1. An application to Endeavour Energy has been made to confirm the requirements for the power supply to the site and any substation requirements. It is estimated that the expected maximum load demand would be of the order of 22,000 kWh. Solar panels would be installed on the roofs of Building 1 and Building 2 to provide a supplementary power supply. Estimates for how much power would be sourced from solar would be made during the next stage of design.

Figure 7.5 shows a 'Potential 11kV electricity connection' which will be required to provide supply to a padmount substation required on the site to facilitate the proposed development.

The applicant and their Accredited Service Provider (ASP) should complete the application for connection of load process with Endeavour Energy's Customer Network Solutions Branch who are responsible for managing the conditions of supply and can be via Head Office enquiries on business days from 9am - 4:30pm on telephone: 133 718 or (02) 9853 6666.

Subject to the foregoing Endeavour Energy has no objection to the Development Application.
