I refer to the Department's below email of 3 December 2019 regarding the request for Updated Planning Secretary's Environmental Assessment Requirements (SEARs) for State Significant Development SSD-10330 Roberts Road Data Centre at 17 Roberts Road, Eastern Creek (Lot 2 DP 1159804). Submissions need to be made to the Department by 31 January 2020.

Endeavour Energy has noted that the submission it made to the original request for SEARs State Significant Development for SSD-10330 received in June 2019 is included in page 18 of the Agency Responses.

As the update / amendment of the SEARs relates to 'the partial construction of Building E3 (up to a height of 15 metres) and associated site preparation works have been removed from the scope of the proposal' the recommendations and comments previously provided by Endeavour Energy remain valid.

Endeavour Energy's Asset Planning & Performance Branch has provided the following update on the provision of electricity supply to the proposed development:

Asset Planning & Performance Branch have received and processed the application for connection of load to this development and provided method of supply for this customer.

This is a two stage development: an initial 11 kilovolt (kV) supply application UIL5583; and a final 132 kV supply application UCL10121.

The two existing switching stations no.s 29057 and 29058 currently connect to this customer will also be used for the first stage 11 kV supply.

The two cables on the southern side of the road, will be cut and redirected to an additional third switching station for this same development.

As such, Endeavour Energy's Network Connections Branch are managing the conditions of supply with the proponent and their Accredited Service Provider (ASP). number of customers providing an ADMD for the site / per lot. Depending on the actual development
proposed for the site, the ADMD provided may not be sufficient.
