Following a conversation with Mr Richard Arkell (Head of Operations) of Meriden School on or about 12 August 2019, I asked him about the condition of the fencing along the northern, eastern and southern boundaries, and he replied, "as far as I know, there was nothing planned for the north property boundary fence", for the eastern he replied "do you want maintenance carried out?". Regarding the proposed southern property boundary (4 Vernon Street), I asked what type of fencing is proposed, and he replied: "nothing has been finalized, only conceptual drawings have been provided." We note that the dialog may not be verbatim what was said but is the best to our recollection.

In regard to the attached photos, the following description are provided to explain why we asked these questions regarding the state of the existing property boundary fencing. These fences provide insignificant noise attenuation. My Family is in great need for noise attenuation.






